Narrative:

On Sunday, July 13, 2025, at 1857 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Kenneth Smith and Middletown Police Detective Pat Glassburn interviewed Timothy McNeely (McNeely), relative to the officer-involved critical incident which took place on Sunday, July 13, 2025. The interview took place at the Middletown Police Department. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

SA Smith and Detective Glassburn sat down with McNeely in an interview room at the Middletown Police Department. SA Smith asked McNeely to take investigators through what had occurred earlier today at his home. McNeely stated that his mother and father had been fighting all week. Today, his mother (Consuelo Denise Kerr) had told his father (Ronald Kerr) that she was leaving him and that they had been arguing about that all day.

McNeely said that his father retrieved a handgun and shot his mother multiple times while she sat on the couch. McNeely said that during the shooting he was in his bedroom, while his parents were in the living room. After McNeely heard the gun shots, he walked into the room, and Ronald pointed the gun at him. McNeely said that he ran out the back door, jumped the fence and ran into his neighbor's house, telling them to call 911.

SA Smith asked McNeely if he had recently fired a gun and he stated he had not. SA Smith established that McNeely was not present when his father had fired the gun. McNeely consented to SA Smith utilizing a GSR kit to determine if McNeely had gunshot residue on his person.

The interview concluded at approximately 1926 hours. The interview was audio and video recorded. The recording is attached to this report. Please see the attachment for further details.
