**Narrative:**

On the morning of December 29, 2020, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) James Gore contacted Shawn Rosemond by phone regarding tip information that Mr. Rosemond had regarding Columbus Police Officer Adam Coy. Mr. Rosemond insisted that he was unjustly arrested by Officer Coy back in 2008, and he mentioned that he previously filed a complaint regarding the arrest.

Rosemond explained that in October, 2008, he was at his home on Indianola Avenue in Columbus with his girlfriend at the time, Christina Carruthers. Carruthers reportedly called the police to report a domestic violence incident between herself and her brother, who Rosemond only could remember by his last name, "Ford." Ford reportedly ran away from the dwelling prior to the arrival of Officer Coy and another officer, who he recalled was "S. Bray." (Note:

Rosemond claimed he was standing outside trying to explain to Officers Coy and Bray what transpired, when Coy asked to see Rosemond's identification. Rosemond further claimed that when he told the officers that the suspect, Ford, had already ran away down an alley, Coy said, "Don't worry about him, we got you." He said he was cornered by the officers against the wall of his porch, and he advised them that he was armed. Rosemond said he was handcuffed and officers then retrieved the handgun from his pocket, which he recalled was a Hi-Point 9mm that had never been fired.

Rosemond explained that after he was placed in the back of the police vehicle, he pleaded with the officers and asked why he was being arrested. Rosemond mentioned that there was an in-car video of Officer Bray asking Officer Coy, "Are you really going to arrest him for CCW?" Officer Coy allegedly responded, "You're damn right I am."

Rosemond admitted that he banged the back of his head on the vehicle window, and Officer Coy then allegedly pulled him out of the vehicle and let his face hit the ground. According to Rosemond, Officer Coy stood him up, then tackled him and slammed him several times on the ground and against the vehicle. He said Officer Bray only told him to stop resisting and was not physically involved. Rosemond reported that other officers then showed up, whereby he was placed in a wagon and transported for about an 45 minutes to an hour. Rosemond conceded that he had been drinking prior to the confrontation. He further stated that he fearful that Officer Coy was going to kill him. Rosemond also mentioned that he didn't understand how the officers said he was resisting when he was already handcuffed and compliant, purportedly.

Mr. Rosemond claimed he was charged with discharging a firearm within city limits, resisting arrest, and carrying concealed weapon. He said he was 35 at the time and had no prior record. He said because he had ineffective counsel from the Public Defender's office, he felt compelled to plead guilty to a charge of "criminal mischief." *(Note: SA Gore determined that Rosemond's counsel of record was Attorney Robert Krapenc, and the plea was to a lesser included offense of disorderly conduct.)*

Rosemond said when he posted bond after his arrest, he sought assistance and filed claims with the National Association for the Advancement of Colored People (NAACP), the Columbus Urban League, and the Columbus Police Internal Affairs Bureau, which he said was on Long St. and Hamilton Ave.

Mr. Rosemond said his sister still has a copy of the in-car video which showed him being removed from the car, but nothing else. Rosemond stated he never learned the results of the Internal Affairs investigation, and he never received assistance from the Urban League or NAACP.

All publicly available records and documents from the Franklin County Clerk of Courts website pertaining to Mr. Rosemond's criminal case from 2008 were attached to this report for reference.
