Details:

On June 28, 2022, at approximately 1200 hrs., S/A Justin Soroka met with Detective Sergeant Tony Starvaggi at 800 Dan St. in the City of Akron. Det. Sgt. Starvaggi had custody of all the items previously collected from the scene by Ohio BCI Agents, as well as the firearms and related items collected by the Akron Police Department's Crime Scene Unit from the involved Officers. Also collected by Akron Police was a cartridge case that was reportedly located where the subject was observed firing a firearm. Det. Sgt. Starvaggi provided S/A Soroka with an inventory receipt, which was signed by Det. Sgt. Starvaggi and S/A Soroka. S/A Soroka took custody of all the items and transported them to the Ohio Bureau of Criminal Investigation in Richfield, where they were secured in temporary evidence locker #10.
