Narrative:

Throughout the investigation, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman compiled background information on Jayden Cole Stephenson, the subject involved in the February 19, 2025, officer-involved critical incident. Specifically, on March 4, 2025, SA Seitzman received prior police reports involving Jayden from Miami Township Assistant Chief of Police James McCarty. On March 7, 2025, SA Seitzman received a work-up of Jayden from BCI Criminal Intelligence Analyst Mallory Naftzger. The information reviewed included criminal history records, open/closed-source database inquiries, and social media posts.

SA Seitzman reviewed the information and noted the following:

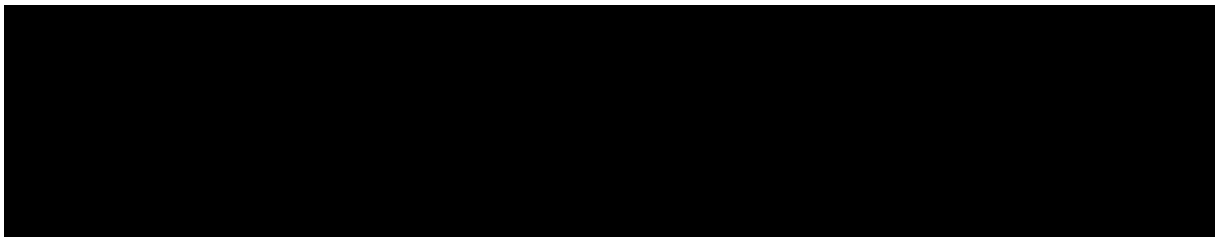
Prior Police Encounters:

- On January 28, 2025, at approximately 0123 hours, Christina Schindler called the Miami Township Police regarding a domestic disturbance. She reported that Jayden was causing property damage within the residence and had used meth a few days prior. According to the notes added to the call, Ms. Schindler did not request any enforcement action and officers stood by while Jayden collected items to leave for North Carolina. A police report was not generated. The call for service log and 911 call are attached to this investigative report (# [REDACTED]).
- On February 17, 2025, at approximately 1502 hours, Miami Township Police were dispatched to Everybody Fitness. The gym manager, Jeffery Haffner, reported that Jayden was engaging in disorderly conduct within the gym, including throwing weights and attempting to fight another patron. Mr. Haffner further reported that Jayden appeared to be under the influence of drugs. Jayden was permanently trespassed from the gym. No police report was generated. The call for service log and 911 call are attached to this investigative report (# [REDACTED]).

- On February 18, 2025, at approximately 0025 hours, Ms. Schindler contacted the Miami Township Police to report another domestic dispute between her and Jayden. She stated that Jayden was breaking items within the residence was exhibiting increasingly violent behavior. During the call, Ms. Schindler could be heard saying, "Oh shit. Jayden! Oh God, Terry, are you okay?" The dispatcher inquired about a mental health diagnosis. Ms. Schindler said he was at Beckett Springs Behavioral Health Hospital approximately eight or nine months ago. She expressed uncertainty about a specific diagnosis and clarified she was unsure if the issue was drug-induced. She advised the dispatcher that Jayden had departed the residence and was driving on expired tags.
 - Once police arrived, Ms. Schindler, and Jayden's grandmother, Terry Bennett, reported that the incident had escalated to a physical altercation. Specifically, Ms. Bennett stated that Jayden pushed her. Ms. Bennett further expressed her suspicions that Jayden had been experimenting with methamphetamine. Ms. Schindler and Ms. Bennett voiced concerns about Jayden's mental well-being, but neither provided the officers with a formal diagnosis. Jayden was subsequently arrested for domestic violence. He was also issued a traffic citation for expired registration, and his vehicle was impounded. The incident report, 911 call, and radio traffic are attached to this investigative report [REDACTED].
- Also on February 18, 2025, following Jayden's release from the Montgomery County Jail, Ms. Schindler contacted the police to report that Jayden was exhibiting delusional and paranoid behavior, specifically, she said he believed individuals were trying to kill him. The notes in the call for service indicated that Jayden did not exhibit any of the behaviors that would warrant involuntary hospitalization for a psychological evaluation. A police report was not generated. The call for service log and recorded call are attached to this investigative report.

Jayden was found to have active Facebook, Instagram, CashApp, and X accounts. He was also the registered owner of a 2015 Dark Blue Kia Optima. Nothing noteworthy located.

Narrative

On February 18th, 2025 officers responded to [REDACTED] for a report of mental health assistance. Officers spoke with Terry Bennett and Christina Schindler, regarding Jayden Stephenson. the reporting parties explained concerns for Jayden. The grandmother, Terry Bennett, stated she was pushed by her grandson, Jayden. Terry stated she suspected her grandson to be experimenting with meth. Terry stated her grandson was released from Beckett Springs in October of 2024, where he received treatment and was given medication. Terry was unable to give specific diagnosis for Jayden's condition, she was able to advise he was taking Lithium. While speaking to the reporting parties, Jayden called his mother and asked her if she would allow him to sleep in his bed. Officer Bishop and Officer Colon waited for Jayden to arrive home.

While waiting for Jayden's arrival, Jayden's mother, Christina, provided a video of her son acting abnormally. He was ranting about trauma, vapes, and different pills. As I was reviewing the video, I heard Officer Colon initiate a traffic stop. The traffic stop was conducted and officers were able to detain Jayden, we placed him in the back of Officer Colon's cruiser.

I read Jayden his Miranda Rights and he stated he understood his rights. After stating he did not wish to speak with officers, I attempted to shut the cruiser door. Jayden inquired repeatedly what was going on and why we were there. I asked him again, if he'd like to speak with officers now and he then stated yes. I asked him what happened earlier and if there was a confrontation. He stated there was and that he didn't, "Give a fuck." I asked him if he pushed anyone today, and he stated yes. Jayden stated he pushed his grandmother and his mother. I advised Jayden he was under arrest for domestic violence. Officer Colon transported Jayden Stephenson to the Montgomery County Jail.

Both reporting parties refused to write written statements.

Jayden was cited for driving with expired registration. His vehicle was inventoried by Officer Bishop and towed by Sandy's.

Three complaints were filed against Jayden Stephenson: One Domestic Violence 2919.25A M1, and two counts of Domestic Violence Threats 2919.25C M4. All three complaints and a traffic citation were faxed to the Montgomery County Jail to be served to Jayden Stephenson.

Supplement

On 02/18/25, at 0025 hours, Officers were dispatched to [REDACTED] for a domestic. Upon arrival I identified the victims as Christina Schindler who was the suspects mother, and Terry Bennett who was the suspects grandmother. The suspect was later identified as Jayden Stephenson.

I watched a video Schindler had on her cell phone of an incident that took place that night. In the video the family was sitting in the downstairs living room. Stephenson stated that he would "merk" both Schindler and Bennett. "Merk" is slang for killing someone.

Supplement

I spoke to the grandmother of Jayden Stephenson identified as Terry Bennett. She said she was standing by the front door attempting to talk to Jayden and get him to calm down. She said Jayden grabbed the door and attempted to open it. When he was doing this he pushed her backward and into the wall behind the door. She said she struck her head on the closet door located on the wall behind the front door. She said she was not injured and she did not need a medic. She told me he was acting erratic and she can normally calm him down, however, she was not able to do so during today's incident. She said he has never struck her in any of the past incidents and that he was being aggressive. The conversation was recorded on my body worn camera. Jayden was transported to the Montgomery County Jail without further incident.
