Narrative:

On Tuesday, November 18, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) received documents from the Trumbull County Sheriff's Office (TCSO) Major Douglas Bobovnyik. The records included any reports pertaining to the November 14, 2025, officer-involved critical incident, except for any statements made by the involved officers. SA Lamping reviewed the documents and noted the following:

The initial three pages of the report consisted of the Computer Aided Dispatch Records from the TCSO Dispatch Center. These records were reviewed in a separate report dealing with the radio traffic from the incident, and as such, were not reviewed in this report.

The initial report was completed by Sergeant Harold Wix (Sergeant Wix). The report lists the date of occurrence as November 14, 2025, from 1651 hours to 2236 hours. The offense was listed as a follow up investigation. The suspect/offender section of the report is pictured below:

NARRATIVE	On November 11, 2025 at approximately 2200 hours while at the Trumbull County Sheriff's Office Major Bobovnyik transferred [REDACTED] taser into my custody. The taser was logged, photographed and placed into an evidence bag with the battery separated from the taser. I placed the taser into a brown paper bag and secured it in temporary locker #3.

NARRATIVE	Trumbull County Sheriff's [REDACTED] and [REDACTED] along with Braceville Police Department [REDACTED] were dispatched by radio by the Trumbull County 911 Center to the area of the 1300 block of St Rt 534, Braceville TWP, for a man in the roadway armed with a handgun and stopping traffic. Upon arrival, officer's encountered a white male subject, later identified as John Adams, who in fact was armed with a handgun. After a few minutes of attempting to negotiate with Adams to drop the gun, officers shot Adams after he pointed the gun in officers direction. Officers immediately called for an ambulance and performed CPR on him. Adams was transported by ambulance to University Hospital in Portage County where he later died. The Ohio Bureau of Criminal Investigation was called to the scene to conduct a criminal investigation.

The TCSO also obtained written statements from two witnesses to the incident. The statements were from Tiffany Brinker and her husband, Jason. The statements were attached to this report where they can be reviewed in their entirety. The statements provided by the Brinkers to TCSO were in line with the statements that they provided to BCI agents at the scene.

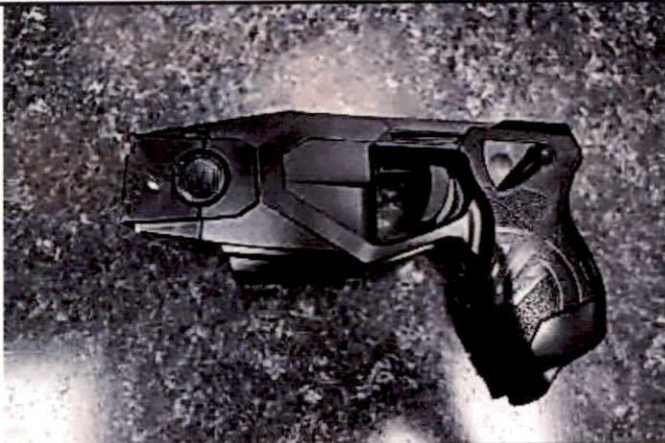

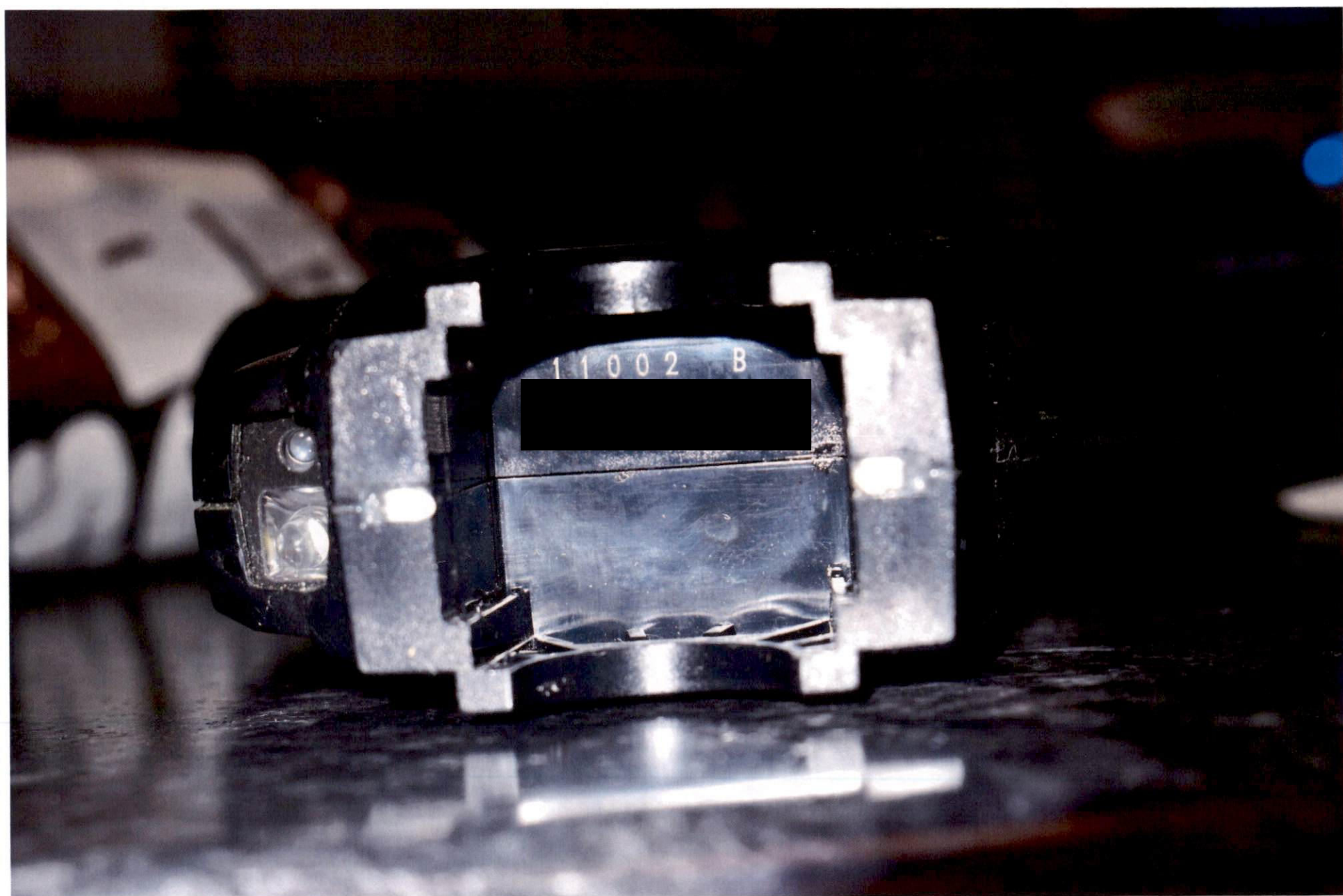
