Swabs of Suspected Blood

DNA STR (Short Tandem Repeat) analysis:

DNA obtained from items 2, 3, 10.1, 10.2, 10.3, 11.1, 11.2, 11.3, 32, 36.2, 37.1, 38.1, 38.2, and 39 was characterized through the Polymerase Chain Reaction (PCR) at the genetic loci Amelogenin, D3S1358, D1S1656, D2S441, D10S1248, D13S317, PentaE, D16S539, D18S51, D2S1338, CSF1PO, PentaD, TH01, vWA, D21S11, D7S820, D5S818, TPOX, DYS391, D8S1179, D12S391, D19S433, FGA, and D22S1045 using the Promega PowerPlex Fusion amplification system.

Results and Conclusions:

The presumptive test indicated the presence of blood in items 2, 3, 10.1, 10.2, 10.3, 11.1, 11.2, 11.3, 38, and 39. No confirmatory testing was performed.

No blood was detected in item 37.

The examination for blood was inconclusive in item 36.

The DNA profile obtained from item 10.2 is a mixture. A likelihood ratio was calculated assuming item 10.2 contained DNA from two unknown contributors. Zachery Edwards Jr. (item 32) cannot be excluded as a contributor to this mixture.

The DNA profile obtained from item 36.2 is a single source of male origin. A likelihood ratio was calculated assuming item 36.2 contained DNA from one unknown contributor.

A match was identified between item 36.2 and Zachery Edwards Jr. This match is:

2.27 nonillion times more probable than a coincidental match to an unrelated African American person, 56.9 decillion times more probable than a coincidental match to an unrelated Caucasian person, and 461 nonillion times more probable than a coincidental match to an unrelated Hispanic person.

The DNA profile obtained from item 37.1 is a single source of male origin. A likelihood ratio was calculated assuming item 37.1 contained DNA from one unknown contributor.

A match was identified between item 38.1 and Zachery Edwards Jr. This match is:

2.27 nonillion times more probable than a coincidental match to an unrelated African American person, 56.9 decillion times more probable than a coincidental match to an unrelated Caucasian person, and 461 nonillion times more probable than a coincidental match to an unrelated Hispanic person.

The DNA profile obtained from item 38.2 is a single source of male origin. A likelihood ratio was calculated assuming item 38.2 contained DNA from one unknown contributor.

A match was identified between item 38.2 and Zachery Edwards Jr. This match is:

2.27 nonillion times more probable than a coincidental match to an unrelated African American person, 56.9 decillion times more probable than a coincidental match to an unrelated Caucasian person, and 461 nonillion times more probable than a coincidental match to an unrelated Hispanic person.

The DNA profile obtained from item 39 is a single source of male origin. A likelihood ratio was calculated assuming item 39 contained DNA from one unknown contributor.

A match was identified between item 39 and Zachery Edwards Jr. This match is:

2.27 nonillion times more probable than a coincidental match to an unrelated African American person, 56.9 decillion times more probable than a coincidental match to an unrelated Caucasian person, and 461 nonillion times more probable than a coincidental match to an unrelated Hispanic person.

The DNA profile obtained from items 10.1, 10.3, 11.1, 11.2, and 11.3 is a single source of male origin and is consistent with the DNA profile of Zachery Edwards Jr.
