Narrative:

On Friday, May 30, 2025, Ohio Bureau of Criminal Investigations Special Agent Richard Ward received from the Middletown Police Department Field Interview Report # [REDACTED] (attached below) authored by Middletown Police Sergeant Jamie Wilcox. The report contained Michael Baker's biographical information with a short summary, which read as follows:

As part of an on-going drug investigation, members of the Special Operations Unit and Uniformed Patrol attempted to serve a narcotics search warrant at 909 Garden Ave. Officers approached the front door of the residence and announced intention of executing a search warrant at the residence. Officers encountered an armed adult male subject at the front doorway of the residence. The investigation was turned over to Ohio BCI.

After completion of search warrant executed by Ohio BCI at the address of 909 Garden Ave, Members of the Special Operations Unit executed search warrant for narcotics at the property. An amount of cocaine, methamphetamine, a safe, numerous items of drug paraphernalia and numerous cell phones were seized. As a result, Alfred Watkins was later booked in the Middletown Jail for drug trafficking Fl, drug trafficking Fl, possession of drugs 2cts and drug paraphernalia. The investigations are on-going at this time.
