SUMMARY:

On Thursday, September 29, 2022, BCI Special Agent(s) Dan Boerner attended the autopsy of Everett Michael Martin, which took place at the Cuyahoga County Medical Examiner's Office (11001 Cedar Ave., Cleveland, Ohio 44106).

DETAILS:

On Thursday, September 29, 2022, at 0945hrs, SA Boerner arrived at the Cuyahoga County Medical Examiner's Office (11001 Cedar Ave., Cleveland, Ohio 44106) to attend the autopsy of Everett Michael Martin (# OU – 2022 – 346). Martin is the deceased subject that was involved in an officer-involved critical incident, which took place on Wednesday, September 28, 2022, in Tuscarawas County Ohio.




Figure 1, Body diagram

On Thursday, September 29, 2022, at approximately 1027hrs, SA Boerner was escorted to the autopsy suite and met with Dr. Alison Krywaczyk who was to perform the autopsy of Martin. During the autopsy, SA Boerner observed multiple suspected ballistic impacts or gunshot wounds to the body of Martin. Subsequently investigation of those injuries revealed suspected ballistic fragments. SA Boerner documented the suspected ballistic impacts or gunshot wounds using a body diagram (Figure 1, Body diagram)¹.
