Narrative:

On Thursday, August 24, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Russell (SA Russell) interviewed Lorraine Krzyzewski (Krzyzewski), relative to the officer-involved shooting which took place on Thursday, August 24, 2023. The interview took place in the parking lot of Kroger, 5991 South Sunbury Road, Westerville, Ohio. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

Krzyzewski stated she was exiting the Kroger store after shopping and saw a Blendon Township police officer, later identified as Officer Conner Grubb (Grubb), assisting an elderly women with a lockout and then saw another officer, later identified as Sergeant Erick Moynihan (Moynihan), arrive a short time later. Krzyzewski added, that she loaded her groceries and upon returning her grocery cart to the corral she heard loud male voices that caught her attention. Krzyzewski stated that she saw one of the officers standing at the driver's side door of a different vehicle with his side arm drawn (left hand) and pointed down at the driver and giving commands and the other officer was in front of the vehicle. Krzyzewski added that she then observed the unknown driver attempt to drive off and she heard two or three loud "pop pops" possibly gunshots and ducked down behind her vehicle to get cover. Krzyzewski added that she then heard the car driving away quickly, then heard it crash. Krzyzewski added. when she stood up she observed the officers opened up the drivers side door and remove the unknown female driver and render aid and CPR. Krzyzewski stated at that point many additional officers arrived from multiple jurisdictions and assisted, followed by a medic a while later.
