Narrative:

On October 30, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of Officer Elizabeth Perez (Officer Perez) during this incident. Officer Perez created seven separate BWC videos relevant to this investigation and all seven videos were reviewed as noted below.

Amped Replay was used to review the videos.

SA Valente made working copies of the seven BWC videos and placed the copied videos in a folder on his BCI issued laptop. The working copies of the videos were used for the review.

The BWC video began as Officer Perez exited her patrol vehicle and began to approach the subject residence on foot. While walking towards the subject residence a voice can be heard saying "Go around back." Officer Perez walked along the south side of the subject property from west to east and took a position at the rear of the subject's home. While walking, Officer Perez asked, "Did you hear what they said?" A voice replied "mhmh." Officer Perz stated, "Um, so the guy apparently has, it's the brother, he has a finger on the trigger and dad's trying to um, calm him down. So, now were setting a perimeter because, um, he obviously has a gun and is ready to use it."

Activity/Notes	As Officer Perez walked across the driveway in front of the open garage door, the man door leading from the garage into the center of the home was captured on her BWC. The man door was closed at the time. A yellow arrow annotation and text box were added to the frame to show the location of the man door.

As Officer Perez stood near the corner of the garage an officer stated over the radio the subject's father was inside the home and (1:28 mark of recording) "there was a gunshot earlier."

As Officer Perez maintained a position near the northeast corner of the garage, other officers could be heard on the radio stating they were attempting to tell the subject's father to exit the home, and they could hear the subject's father telling the subject to take his finger off the trigger (of the gun).

While standing at the back of the home near the garage, Officer Michael Dugan's voice was captured on Officer Perez's BWC clearly and loudly asking the subject's father to please come outside. Officer Dugan repeated this request multiple times without receiving a response. While Officer Dugan repeated his request, the subject and his father could be heard arguing inside the home.

Activity/Notes	A voice, which appeared to be the subject's, could be heard beginning to say "I would never do that. Dude! I would never!" Officer Dugan replied, "Hey, come out with your hands up man." The voice, apparently coming from inside the home, replied, "I would never [unintelligible]." As this conversation occurred, Officer Perez changed position slightly from looking towards the three-season room to looking into the garage where the voice seemed to be coming from. As the conversation ended, Officer Perez stated over her police radio, "We have the male at the back door."

As Officer Perez continued to hold a position at the back of the home near the garage door, additional police radio traffic could be heard on her BWC. This additional traffic included:


- officers requesting a hostage negotiator
- officer requesting an EMS vehicle stage nearby
- officers requesting EDGE SWAT team members be notified and respond if available
- the subject's father exiting the home
- the subject possibly being under the influence of psychedelics
- and an officer reporting seeing the subject at the front door of the home with a gun in his hand.



Activity/Notes	Officer Perez began to loudly exclaim "Show me your hands! As Officer Perez finished giving this order a loud percussive sound consistent with a gunshot began.

As the sound of the first gunshot ended, Officer Perez again exclaimed, "Hands!" An officer is then heard on the radio stating "shots fired." An unknown voice then yelled out in surprise. Officer Perez then yelled out again, "Hands!



Activity/Notes	The first in a group of quickly spaced loud percussive sounds consistent with gunshots began. As the sound of apparent gunfire rang out, Officer Perez again repeated her command, "Show me your hands!" As the apparent gunfire continued, a voice consistent with Officer Dugan's can be heard asking, "Where the fuck, where the fuck is he?" A female voice replied to the question as it was being asked, "I have no idea." A female voice then exclaimed "Over there, over there!"

	The last loud percussive sound consistent with a gunshot began at/near this frame.

After an officer could be heard stating they were beginning to render aid to the subject, Officer Perez ran around the east side of the subject's home to the front yard. Once in the front yard of the home, Officer Perez was met by multiple other police officers and member of the subject's family. Officer Perez spoke with Ferrel Thomas (Ferrel), father of the subject. Officer Perez told Ferrel he could not enter the home at the time.

Around the 00:27:09 mark of the recording Ferrel stated aloud, "I done fuckin' failed." Ferrel then asked the group of officers near him, "Did y'all kill my son? Did y'all have to kill him? No one responded to Ferrel's questions. Ferrel began to walk away and said something unintelligible. Ferrel then turned around and angrily asked "Who the fuck told me to come outside? Who the fuck, who, which one of y'all told me to come outside? I wanna know. answer to because he was fuckin' okay!" Officer Perez interrupted the end of Ferrel's statement and asked him what his question was. Ferrel yelled, "Who the fuck told me to come outside?" Officer Perez responded, "I think we all did. We wanted to get you outside, to talk to you, see what was going on inside." Ferrel interrupted, angrily asking, "So y'all could fuckin kill him?" Officer Perez responded, "absolutely not." Ferrel replied, "I know y'all didn't want to." Officer Perez then attempted to get Ferrel to sit with his daughters who were also in/near the front yard.

Officer Perez then escorted Genisis Thomas into the home and stood by with her as she removed some personal property from her bedroom.

All frames referenced above, except for the start time and end time frames, were bookmarked as images in Amped Replay. The images were exported to the folder "Ofc. Perez BWC 1 Derivatives and Reports."

An Amped Replay report was generated for Officer Perez's first BWC video review and bookmarked images. The report was exported to the same folder noted above. The video began 30 seconds after the conclusion of the previous BWC video. As this BWC video began, Officer Perez was still inside the Thomas family home and was awaiting Genisis Thomas to exit her room after changing clothes and packing a small number of personal items to take with her for the night.

Once back outside the home, Officer Perez briefly spoke with an individual who stated she was the grandmother of the subject and assisted in uniting family members of the subject.

Officer Perez then spoke with neighboring residents inquiring about possible video surveillance that may have captured the shooting.
