Narrative:

On January 7, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) reviewed Sergeant Noah Kocher's (Kocher) bodyworn camera (BWC) in relation to the December 7, 2024, officer-involved critical incident that occurred at 234 Mansfield Avenue, Shelby, Richland County, Ohio 44875.

SA Harasimchuk located Sergeant Kocher's BWC video file in Axon's evidence.com. The video file was titled as follows; Kocher_BodyCam.

SA Harasimchuk made a working copy of the video and placed it in a folder on his BCIissued laptop. The working copy of the video file was used for review.

SA Harasimchuk imported the video file into Amped Replay for review.

Kocher_BodyCam

SA Harasimchuk reviewed the video file labeled, "Kocher_BodyCam." SA Harasimchuk noted the following information:

- The video-embedded timestamp dates were 2024-12-07.
- The video-embedded timestamp start time was 23:18:07.
- The video-embedded timestamp end time was 23:33:09.
- The video file was from Digital Ally BWC.
- The camera was fixed to Sergeant Kocher.
