Narrative:

On [REDACTED], the investigation regarding the Officer-Involved Critical Incident (OICI) that occurred in Brooklyn, Ohio, on February 24, 2026, was presented to a Grand Jury in the Cuyahoga County Court of Common Pleas by the Ohio Attorney General Office, Special Prosecutions. The Grand Jury declined to file criminal charges regarding the actions of Parma Police Department [REDACTED] and [REDACTED] in relation to the death of Ricardo Yuuki Davis.

On Wednesday, August 5, 2026, and Wednesday, August 26, 2026, the evidence in this case, which had been stored in the property room of BCI-Richfield, had been returned to Parma Police Department Detective Marc Karkan. Special Agent Douglas Burke and Special Agent Supervisor Charles Moran reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.

The documents received from the Ohio Attorney General Office, Special Prosecutions, Cuyahoga County Clerk of Courts, and Evidence Return Receipts are attached to this report. Please refer to those documents for further information.
