Narrative:

On Wednesday, May 5, 2021, the Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau arrived at Mount Carmel St. Ann's Hospital (495 South Cleveland Ave., Suite 200, Westerville, Ohio) in order to obtain records requested prior to this date pursuant to a subpoena service; also served prior to this date. The purpose of the subpoenaed records was to request medical records relevant to an Officer–Involved Critical Incident (OICI), which occurred at St. Ann's Hospital (500 South Cleveland Ave, Westerville, Ohio) on April 12, 2021. BCI learned Columbus Police officers were taking Miles Jackson (involved subject) into custody at St. Ann's Hospital Emergency Department (ED) room #9. A struggle ensued and CPD officers and St. Ann's (armed) Security officers discharged their duty weapons. Miles died from apparent gunshot wounds.

SAS Barbeau received an encrypted CD with a password. SAS Barbeau reviewed the medical records contained on the CD and these electronically saved and attached below. The CD was entered into the physical case file and the records attached below should be reviewed for additional details.

Upon reviewing the below medical records the following was noted:
