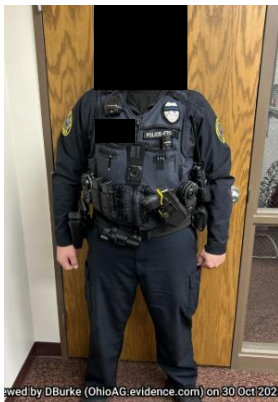

**Narrative:**

On Wednesday, October 22, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Douglas Burke (Burke) arrived at Findlay Police Department (FPD), 318 Dorney Plaza Suite 116, Findlay, OH 45840 in reference to an Officer-Involved Critical Incident (OICI). Upon arrival, SA Burke made contact with Ohio Patrolmen's Benevolent Association (OPBA) Attorney (Atty.) Yvonne Trevino (Trevino) who represented the Officers with FPD.

Atty. Trevino stood by as SA Burke made contact with the officers involved, Officer [REDACTED] and [REDACTED] in the office of Captain (Cap.) Justin Hendren (Hendren) at approximately 1629 hours on October 22, 2025. SA Burke photographed [REDACTED] and [REDACTED] in their uniform of the day at the time of the OICI.

**Firearm Description**

- Glock Model 45, 9mm, SN: [REDACTED] with one (1) live round in the chamber and fourteen (14) rounds in the magazine. Firearm consisted of an AimPoint COA-red dot with a TLR-7 HL-X StreamLight.

SA Burke asked [REDACTED] how many shots he believed he had discharged from his firearm. [REDACTED] believed he had discharged two (2) or three (3) rounds from his firearm at the time of OICI. At the time of the OICI, [REDACTED] told SA Burke that he had a full magazine of seventeen (17) rounds in the magazine and one (1) round in the chamber. SA Burke asked [REDACTED] if any of the two (2) spare magazines [REDACTED] carried were used during the OICI and he stated that they were not. SA Burke asked [REDACTED] if he used any less lethal weapons during the OICI and [REDACTED] said he did not. SA Burke photographed and collected [REDACTED] firearm and magazine used in the OICI.

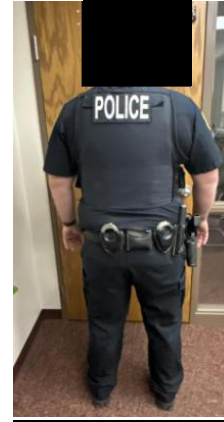

## Firearm Description

- Glock Model 21, .45 caliber, SN: [REDACTED] with one (1) live round in the chamber and nine (9) rounds in the magazine. Firearm consisted of iron sites and a TLR-1 StreamLight.

SA Burke asked [REDACTED] how many shots he believed he discharged from his firearm. [REDACTED] believed that he discharged two (2) to four (4) rounds from his firearm at the time of the OICI. At the time of the OICI, [REDACTED] told SA Burke, he had a full magazine of thirteen (13) rounds in the magazine and (1) round in the chamber. SA Burke asked [REDACTED] if any of the two (2) spare magazines [REDACTED] carried were used during the OICI and he stated they were not. SA Burke asked [REDACTED] if he used any less lethal weapons during the OICI and [REDACTED] said he did not. SA Burke photographed and collected [REDACTED] firearm and magazine used in the OICI.

The firearms, loose rounds, and magazines suspected of being used at the time of the OICI were collected as evidence. A BCI Inventory/Receipt was completed, then emailed to Lt. Andrew Welch of FPD.

Throughout the initial contact with the involved officers from FPD, it was learned FPD is in the midst of a firearm transition. FPD is transitioning from Glock Model 21, .45 caliber firearms to Glock Model 45, 9mm firearms. [REDACTED] had recently been issued and qualified on his new Glock Model 45. [REDACTED] had not yet been issued a new Glock Model 45 and used his Glock Model 21 at the time of the OICI.

SA Burke spoke with Atty. Trevino about the involved-officer and witness officer interviews. Atty. Trevino and the officers requested those interviews to be conducted at a later date to be determined.

The items of evidence from the officers involved were given to Crime Scene Technician (CST) Emily Miller (Miller) who transported them to the Bowling Green BCI Office. CST Miller also transported evidence from the scene to the Bowling Green BCI Office.

The photographs of the involved-officers and their firearms were uploaded into Axon Justice under Reference Item E-Involved Officer Photo's, sub-folder named Involved Findlay PD [REDACTED] and sub-folder named Involved Findlay PD [REDACTED]
