Special Agent Cory Momchilov created a timeline of the events leading up to the June 27, 2022, officer-involved shooting.

It should be noted that not every event is documented in the timeline, only the most relevant information that the author deemed related to the incident. Also, Jayland Walker (Walker) received numerous text messages after the death of Jaymeisha Beasley, in which individuals were offering condolences and "checking" on Walker. The vast majority of those text messages are not included in this timeline.
