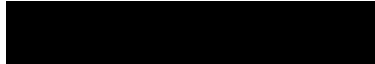

On January 26, 2024, you were involved in a use of force during an arrest. You deployed your Taser against the non-compliant subject. During this incident, your body worn camera was in sleep mode, causing it to not capture the incident in violation of policy.

## PERFORMANCE RECOGNITION



1/20/2023 EMAIL COMPLIMENT

Sergeant Justin Poe wrote a complimentary email commending you for your role in the arrest of a rape suspect and the investigation of the incident which occurred on May 19, 2022. At the conclusion of the criminal trial, the suspect was convicted of Rape and Gross Sexual Imposition.

1-7-2021 WRITTEN COMMENDATION

Lieutenant Randy Beane commended you for your actions on May 30, 2020, when protest were held at the Federal Building in response to a controversial police incident in Minneapolis MN. The protest began peacefully then escalated with individuals becoming more disruptive, damaging property and throwing items causing a state of emergency to be declared and a curfew imposed downtown. As a member of the Regional Crowd Management Team (RCMT) you responded and helped disperse the disorderly crowds, operating most of the day in an environment of chemical irritants and protesters. Over the next several months, the RCMT worked over 50 protests within the City of Dayton and surrounding jurisdictions.

11-15-19 WRITTEN COMMENDATION

Lieutenant Mark Ponichtera commended you for your actions after the November 4, 2019, shooting of Detective Jorge Delrio which resulted in his death. You and other members of the Dayton Police Honor Guard stepped forward to begin a silent vigil, which culminated in an honor walk at Grandview Hospital and full honors police funeral at the University of Dayton Arena. You each planned every aspect and detail of the viewing, and subsequent funeral, all while standing guard and grieving the loss of our fallen brother. Every detail was meticulously reviewed, assigned and catalogued, which ultimately led to a stunning and honorable service, attended by thousands of officers around the nation

1-4-18 WRITTEN COMMENDATION

You were commended by Sgt. Theodore Trupp for your actions on Dec. 29, 2017 when you along with Officers Nicholas White and Alaina Hammond were dispatched to 216 Huron Ave. on the report of a dangers animal complaint. Mr. William Talbott had been mauled by two pit bulls and had multiple injuries to his body. Officer White fired two rounds at the pit bulls striking each dog once causing them to retreat to the rear of the yard allowing you to retrieve a first aid kit to render aid to the victim. Due to your quick thinking, calm demeanor and sound decision making your actions undoubtedly saved the life of the victim in this tragic accident.

9-4-17 WRITTEN COMMENDATION



You were commended by Sgt. Ryan Halburnt for your actions on Sept. 2, 2017 when you were dispatched to SunWatch Indian Village/Archaeological Park due to unknown individuals cutting locks on their gates, trespassing through their property and stealing vehicles from a junk yard that bordered their land. Because of your sound decision making and attention to detail you recovered a stolen vehicle and helped identify suspects in a multi-state crime syndicate.

11-16-16 WRITTEN COMMENDATION

Sergeant Andrew Zecchini commended your keen observation skills, aggressive police work and dedication to your duties regarding November 15, 2016, when you and Officer Jason Berger were dispatched to the area of Middlehurst Lane and Piccadilly Avenue on the report of an individual shooting a firearm. You and your partner quickly responded to the vicinity and located a suspect. The apprehension resulted in finding a large amount of uncut cocaine that you later determined weighed 162.96 grams and had a street value of \$13,000.

09-21-16 WRITTEN COMMENDATION

Sergeant Matthew Osterday commended your dedication to duty and relentless pursuit of justice resulting in the arrest of a suspect in a breaking and entering in progress at the Germantown Plaza Drive-Thru.

04-26-16 WRITTEN COMMENDATION

Lieutenant Mark A. Ponichtera commended your intervention resulting in the removal of a violent offender from the streets of our community. The incident occurred on March 1, 2016 at 2100 hours and involved the capture of a suspect GTA and Kidnapping suspect that occurred at the AM/PM market at 2317 Salem Avenue.

08-14-14 WRITTEN COMMENDATION

Sergeant Creigee S. Coleman commended your quick thinking and ability to relay vital information to crews resulting in a violent criminal being removed from the streets of the City of Dayton. On July 27, 2014, you were dispatched on an Assault complaint at 510 Oxford Avenue. Comments on the call stated the suspect left the residence and possibly possessed a shotgun and the suspect was threatening to shoot his girlfriend and set fire to her house. You arrived and while on scene, the suspect called several times stating he was coming back to the house to cause harm to the victim. While the suspect was on the phone with the victim, you quickly relayed the information to responding crews the whereabouts of the suspect. You continually gave crews accurate updates as to the suspect's every movement. You alerted crews the suspect had arrived back at the residence and at that point, he was quickly apprehended by officers.
