- <u>Medical Records-</u> 149.43(A)(1)(a). Information obtained from medical records redacted. R.C. 149.43(A)(1)(a).
- <u>PII (confidential personal information)</u>- Personal information as defined by Ohio Revised Code Chapter 1347 is not a public record pursuant to R.C. 149.43(A)(1)(v).
- Portions of a body-worn camera or dashboard camera recording that shows, communicates, or discloses any of the following:
- The image or identity of a child or information that could lead to the identification of a child who is the primary subject of the recording;
- <u>LE firearm Serial Number and other security records-</u> Law enforcement firearm serial number, pursuant to R.C. 149.433
