Narrative:

On September 10th, 2024, Special Agents (SA) Kevin Wagner, Chad Holcomb, and Brittney VanBibber were assigned to assist the Columbus Police Department (CPD) with an officer involved critical incident (OICI). Columbus PD had been dispatched to a house several addresses down from the CPD building, located at 248 E 11th Avenue, multiple times during the night of September 9th and the morning of September 10th in reference to a suicidal male with knives. A short while later, Columbus PD received an additional call about a subject with a knife at the same address. CPD [REDACTED] walked outside the back of their district building and discovered the male, Lamine Mahmoudi (Mahmoudi) outside with multiple knives in-hand. After a brief confrontation, the CPD officers discharged their firearms, striking and killing Mahmoudi. A sixth officer discharged a taser at Mahmoudi. He was pronounced deceased on scene, and his body remained in the lot. The CPD officer's firearms were processed and collected by SA Holcomb (see scene #2 report).

SA Wagner arrived at the scene at 0445 hours. The parking lot of CPD district 4 was cordoned off with crime scene tape, with multiple CPD marked cruiser around the lot. The body of Mahmoudi was near the curb on the North side of the parking lot. SA Wagner documented the scene through photography. A Leica BLK360 3D scanner was also utilized to collect measurements and raw data of the scene.

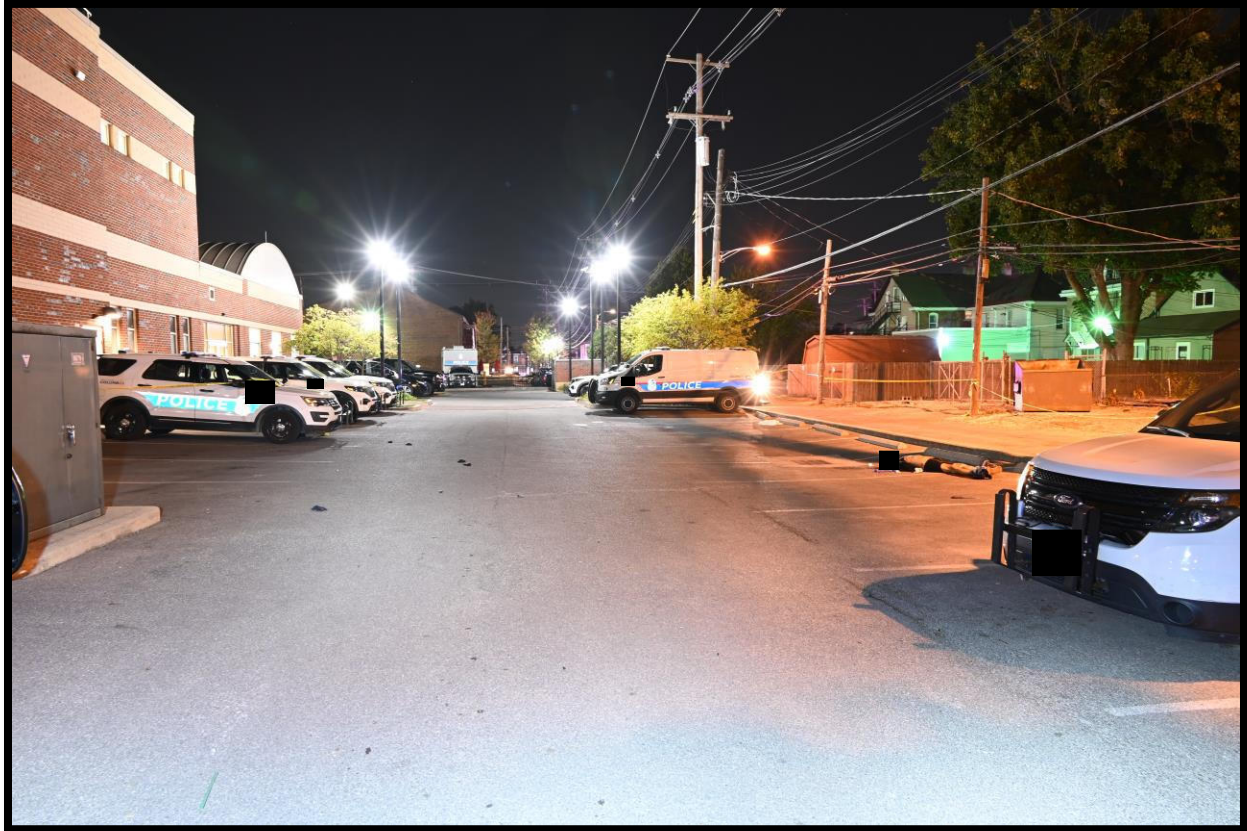


Image 1 – CPD District 4 parking lot at 248 E 11th Ave in Columbus

Mahmoudi's body was found supine on in the parking lot. SA Wagner documented Mahmoudi's body with assistance from a FCCO coroner's investigator. Multiple suspected gunshot wounds were observed in various locations on his body. His hands were still handcuffed behind his back. The handcuffs were later released back to CPD with assistance from the Franklin County Coroner's Office (FCCO). A folded pocketknife (item 28) was collected from his pants pocket, and two projectiles (items 29 and 30) were collected when they fell out of his clothing.

Near Mahmoudi's body were two knives (meat cleaver and long kitchen knife) that were collected together as item 6. Taser cartridge components were collected from the middle of the parking lot as item 7. An additional projectile (item 27) was located near Mahmoudi's body, on the concrete.

A total of twenty-three (23) 9mm Speer casings were located in the parking lot. They were collected separately, and are listed as items 1-5, and 8-25.

A Honda CRV (Ohio license EWX6006) and a Ford F-150 (Ohio license JTW3806) that sat behind 259 Chitten Ave (one street over) were both struck by CPD officer's gunfire. A single ballistic event (BE) was located on the rear tailgate of the F-150 and was listed as BE 1.0. Two BEs were observed in the rear bumper of the CRV and were labeled as BEs 2.0 and 3.0. A fourth suspected BE was located in a glass window of the building of 259 Chittenden Ave and was labeled BE 4.0. Underneath the CRV, was an additional projectile collected as item 26.

SA Holcomb released custody of items 1-5 from scene #2 (CPD officers firearms) to SA Wagner.

No additional items of evidentiary value were located on scene. SA Wagner cleared the scene at approximately 0845 hours.

Items 1-30 from scene #1 and items 1-5 from scene #2 were transported to the main BCI headquarters. Items 1-5, 8-27 and 29-30 from scene #1 were all submitted to the BCI laboratory for firearms comparison at 0925 hours. Items 6-7 and 28 from scene #1 were taken upstairs and submitted to BCI temporary evidence locker #1 to be put in the major crimes evidence vault at 1000 hours. Items 1-5 from scene #2 were submitted to the BCI laboratory for firearms comparison at 0925 hours.
