Narrative:

On December 22, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agents Perry Roeser and Richard Ward attended the post-mortem autopsy examination of Todd Jordan at the Montgomery County Coroner's Office located in Dayton, Ohio. The examination started at 0730 hours and was performed by Forensic Pathologist Dr. Bryan Casto.

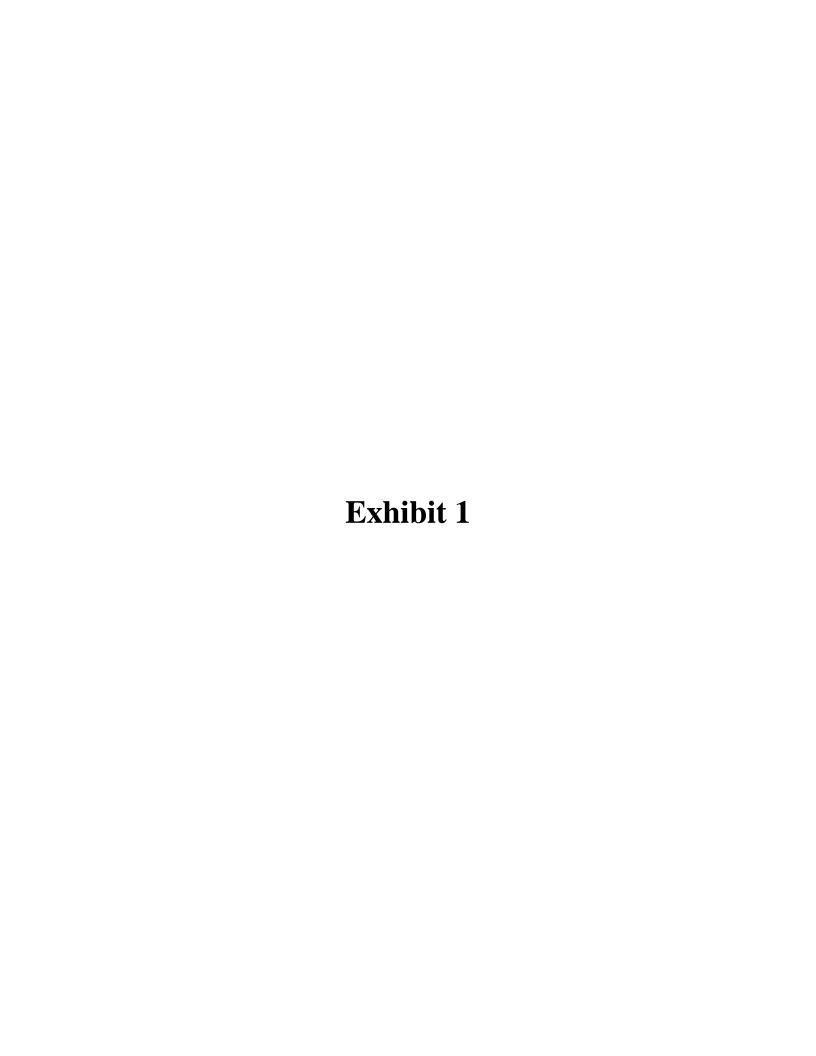
SA Roeser received all evidence from the autopsy and transported the items to BCI, London, Ohio. The chain of custody paperwork (attachment #1) has been uploaded into the case file and attached to the report. SA Roeser placed the evidence in the third-floor temporary locker system for safekeeping.

SA Roeser requested a copy of the official coroner's report for Todd Jordan from Shelby County Coroner's Office Investigator Rod Austin. Austin forwarded SA Roeser the requested report. The report was reviewed and placed into the case file. See attachment #2.
