**Narrative:**

On January 1, 2022, at 0213 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) responded to Aultman Hospital in Canton, OH, in reference to an officer-involved shooting that occurred earlier that morning involving a subject, James Williams (Williams), and an officer with the Canton Police Department (CPD).

SA Moran learned that the male subject, Williams, was deceased. SA Moran also learned that there was difficulty contacting the Stark County Coroner's Office.

SA Moran met with Aultman Security Services Officer (ASO) Ryan Smith (Smith). ASO Smith escorted SA Moran to Trauma Room A where Williams' body was located. The body was covered with a sheet and the hands were bagged. SA Moran did not disturb or view the body.

Williams' clothing and belongings were in bags on the floor inside the room. SA Moran took photographs of the clothing. The clothing consisted of:

- Pair of shoes, brown color
- Underwear, purple, black and white color
- Sweatpants, blue and yellow color

SA Moran took photographs of Williams' Ohio driver's license, wallet, U.S. Currency and pack of cigarettes. These items consisted of:

- Ohio driver's license, James Williams
- Wallet, multiple cards inside of it, brown color
- Newport cigarettes, purple lighter inside package
- U.S. Currency, \$397.00 total (breakdown: \$50.00 x1, \$20.00 x17, \$5.00 x1, \$1.00 x2)\*

(\*Note: The U.S. currency was counted by SA Moran with ASO Smith present. SA Moran and ASO Smith verified the amount of U.S. currency.)

SA Moran took custody of the items and an evidence receipt was completed and signed by SA Moran and ASO Smith at 0314 hours.




