Narrative:

On Wednesday, December 4, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent Allison Fletcher (Fletcher) and SA Dan Boerner (Boerner) photographed and examined Jazmir Tucker's (Tucker) personal property which included the following items:

- Shirt (Matrix Evidence Item #28)
- Pair of socks (Matrix Evidence Item #26)
- Tennis shoes (Matrix Evidence Item #25)
- Underwear (Matrix Evidence Item #24)
- Pants (Matrix Evidence Item #23)
- Jacket (Matrix Evidence Item #22)
- Coat (Matrix Evidence Item #21)

Evidence collected during the autopsy on November 29, 2024, was also photographed and examined. The following two items were removed from Tucker during the autopsy:

- Bullet jacketing fragments (Matrix Evidence Item #20)
- Bullet and fragments (Matrix Evidence Item #19)

All items were repackaged as evidence. SA Fletcher noted the following defects on the articles of clothing:






