On Saturday, February 25, 2023, the Ohio Bureau of Criminal Investigation (BCI) was contacted by the Middletown Police Department in Butler County, Ohio, to assist with an Officer-Involved Critical Incident that occurred at the Walmart, located at 2900 Towne Boulevard, Middletown, OH (Warren County) between the subject, Victor Lykins, and the Middletown Police Department.

On March 15, 2023, Ohio BCI Special Agent Lauren Frazier obtained a search warrant through Madison County Court for the blue Samsung cell phone belonging to Victor Lykins. The search warrant was signed by Madison County Common Pleas Judge Eamon Costello on March 15, 2023. A copy of the search warrant is uploaded in Matrix.

On March 15, 2023, Ohio BCI Cyber Crimes Unit was given a copy of the search warrant to assist with extracting the cell phone contents. On March 21, 2023, SA Frazier received the phone extraction. The contents were reviewed and below is a summary of the findings:

Victor's call log shows that he received two phone calls from his brother, Robert "Kelly" Lykins, on February 24, 2023 at approximately 11:00 pm and 11:54 pm.




