On August 11, 2024, the Ohio Bureau of Criminal Investigation (BCI) investigated an Officer Involved Critical Incident involving the Columbus Police Department (CPD) and The Ohio State University Police Department (OSUPD). Special Agent (SA) Mathew Austin (SA Austin) from the BCI Crime Scene Unit responded to assist. SA Austin was requested by SA Aja Chung to report to the above address to document the involved law enforcement officers and to collect necessary evidence.

SA Austin arrived to CPD Substation 4 at approximately 1455 hours and was accompanied by Crime Scene Technician (CST) Dylan Wical. A total of five (5) involved officers were documented through photography and their duty pistols were collected. Two (2) additional officers who were witnesses were also photographed.

██████████ had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed on his right side and ██████████ advised he had it on during the incident. SA Austin collected his duty pistol, a Smith & Wesson M&P9 M2.0 ██████████ that was found with a 9mm cartridge in the chamber with a magazine containing 15 additional cartridges. Two additional magazines that appeared to have 17 cartridges were collected together with the pistol as item 1.



██████████ had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed on his right side and ██████████ advised he had it on during the incident. SA Austin collected his duty pistol, a Smith & Wesson M&P9 M2.0 ██████████ that was found with a 9mm cartridge in the chamber with a magazine containing 17 additional cartridges. ██████████ had one magazine containing 17 cartridges on his duty belt and an empty slot for an additional magazine. ██████████ reported his other magazine was left inside the residence during the incident. The pistol, cartridges, and two magazines were collected together as item 2.

██████████ (CPD Badge ██████████) *Involved Officer*

██████████ had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed on his right side and ██████████ advised he had it on during the incident. SA Austin collected his duty pistol, a Smith & Wesson M&P9 M2.0 ██████████ that was found with a 9mm cartridge in the chamber with a magazine containing 13 additional cartridges. Two additional magazines that appeared to have 17 cartridges were collected together with the pistol as item 3. A weapon mounted light that was affixed to the pistol was removed and returned to ██████████

██████████ (CPD Badge ██████████) *Involved Officer*

██████████ had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed on her right side and ██████████ advised she had it on during the incident. SA Austin collected her duty pistol, a Smith & Wesson M&P9 M2.0 ██████████ that was found with a 9mm cartridge in the chamber with a magazine containing 17 additional cartridges. One of the two magazines on her duty belt appeared to have 17 cartridges in it and the other was confirmed to have seven (7) cartridges in it. ██████████ stated she conducted a magazine change with retention during the incident. The pistol, cartridges, and three magazines were collected together as item 4.



██████████ (OSUPD Badge ██████████ *Involved Officer*

██████████ had on a blue, marked OSUPD uniform with discrete body armor and a polo shirt. An empty body worn camera (BWC) mount was observed centered on her mid-chest and ██████████ advised she had it on during the incident. SA Austin collected her duty pistol, a Glock 17 Gen 5 ██████████ that was found with a 9mm cartridge in the chamber with a magazine that appeared to contain 17 cartridges. ██████████ had one magazine containing 17 cartridges on her duty belt and an empty slot for an additional magazine. ██████████ reported her other magazine was left inside the residence during the incident. The pistol, cartridges, and two magazines were collected together as item 5.

### **Deann Trionfante (CPD Badge #1484) *Witness Officer***

Officer (Ofc.) Trionfante had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed on her right side and Ofc. Trionfante advised she had it on during the incident. SA Austin photographed her duty pistol, a Smith & Wesson M&P9 M2.0 [REDACTED] It was found with a 9mm cartridge in the chamber with three magazines that all appeared to contain 17 cartridges. Ofc. Trionfante reported her right eye was injured during the incident and SA Austin observed that the lower corner of her right eye appeared bloody.

██████████ had on a blue, marked CPD uniform with external vest carrier. An empty body worn camera (BWC) mount was observed centered on his chest and ██████████. ██████████ advised he had it on during the incident. SA Austin photographed his duty pistol, a Smith & Wesson M&P9 M2.0 ██████████. It was found with a 9mm cartridge in the chamber with three magazines that all appeared to contain 17 cartridges.



SA Austin and CST Wical cleared this scene at approximately 1555 hours and turned over the five pistols (items 1-5) to SA Chung while assisting at scene 3.
