**Narrative:**

On April 13, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (Bynum) and Special Agent Supervisor (SAS) Charles Moran (Moran) reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.


