On January 15, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) made a records request to the Summit County Juvenile Court. SA Lieber had previously spoken with the Court Clerk's office and was notified that in order to obtain records, a written request needed to be faxed to the court. The request would then be reviewed by the Judge.

The Ohio Bureau of Criminal Investigation (BCI) is investigating an incident (Case #2024-3775) that occurred on November 28, 2024. The incident involved a confrontation between Akron Police Department officers and Jazmir Tucker (DOB 03/11/2009). The incident resulted in Jazmir Tucker's death. During the investigation it was learned that Tucker may have been charged with Disorderly Conduct stemming from an incident that occurred on September 20, 2024, at the North High School in Akron, OH. BCI is making a formal request for any records the Court may have regarding this incident as well as any other incidents involving Tucker that occurred between November 28, 2023 to November 28, 2024.
