On January 31, 2023, at approximately 1155 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Todd Clark obtained records of treatment Zachary Zoran (Zoran) received from The Light Center Recovery pursuant to a search warrant previously served on the organization.

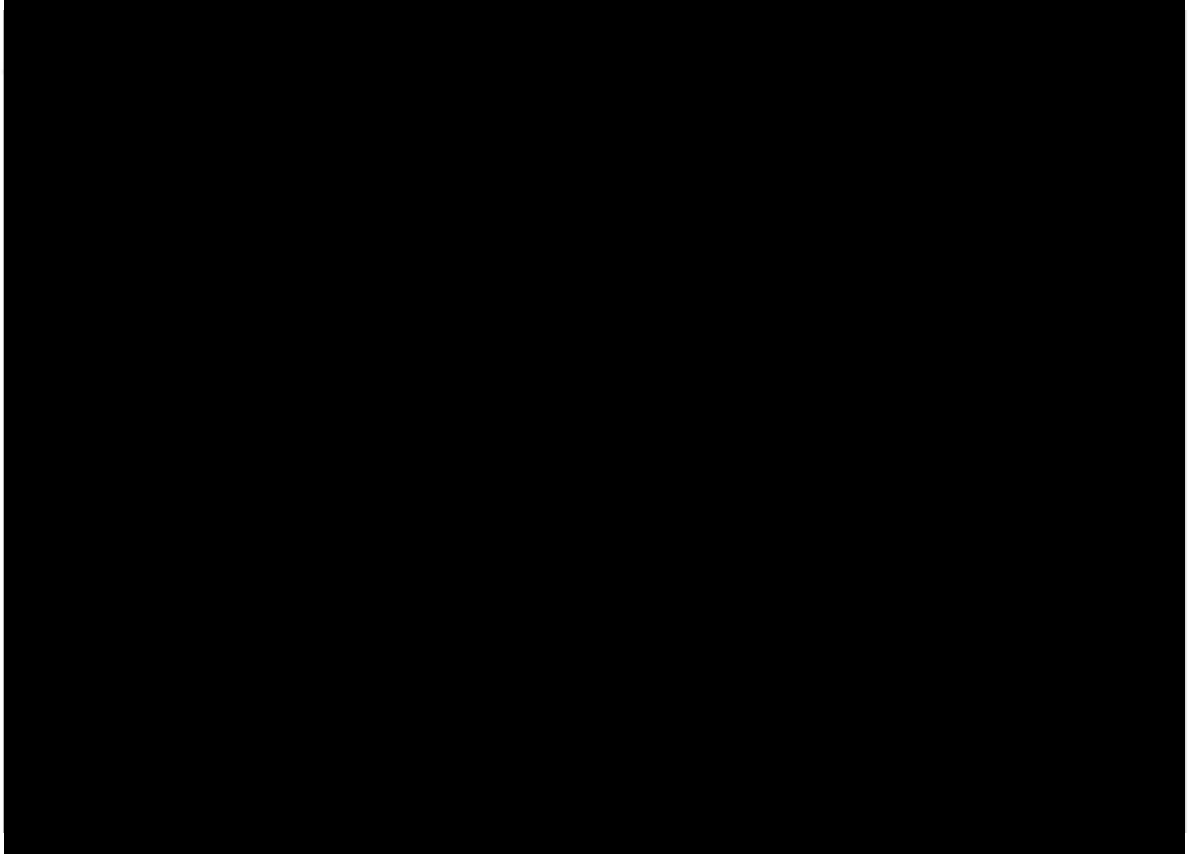
