**Narrative:**

On Monday, November 7, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) reviewed video footage and still photographs provided by the Delaware Police Department (DPD) Drone Unit. SA Tingley was informed that the multiple videos and photographs contained footage and still imagery from the DPD drone, related to an officer-involved critical incident which occurred on August 20, 2022, at 15266 Gilchrist Road, Mt. Vernon, Knox County, Ohio.

There are four (4) main files/folders, with each of the main files/folders having secondary folders contained within. Furthermore, the secondary folders are also separated into multiple folders.

As there is no date or timestamp on these videos or photographs, the time listed, where applicable, will be the progression of the video from the beginning of the video.

Also, for purposes of this report, the residence, which will be described as the "mother's residence," is the residence on the property at 15266 Gilchrist Road and is where Sandra Wilhelm resides.
