Narrative:

On March 16, 2021, Ohio Bureau of Criminal Investigation (BCI) Special Agent Jim Mulford spoke with Franklin County Prosecutor's Office, Chief Counsel-Grand Jury Unit Marla Farbacher (Farbacher) regarding the fatal shooting incident between Andrew Teague (Teague) and members of the Columbus Division of Police (CPD) and Franklin County Sheriff's Office (FCSO).

She was informed the 2016 Kia driven by Teague during the incident had been searched and was currently being housed until further notice.

Farbacher instructed SA Mulford to release the vehicle. She sent a follow-up email confirming the conversation. That email was saved electronically and is attached to this report.

Later this date, SA Mulford confirmed with Columbus Division of Police Sergeant Terry McConnell (Sgt. McConnell) that the vehicle will be released to its registered owner.
