**Narrative:**

On August 8, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) received a collection of records from the Ashland County Sheriff's Office (ACSO) related to the death of Larry Dunham. One of these documents was a PDF which consisted of the following:

- ACSO Incident Report
- Jeromesville Fire Department (JFD) EMS Run Report
- ACSO Use of Force Report
- Crime Scene Log.

SA Valente reviewed the reports and noted the following:

ACSO Incident/Offense Report: 202300684:

This report included a single narrative written by ACSO Sergeant Dan Saylor (Sergeant Saylor). In his narrative, ACSO Sergeant Saylor wrote Jeromesville Fire Department employee Brandon Glass entered the crime scene and confirmed the male (Larry Dunham) was deceased at an unspecified time. ACSO Sergeant Saylor also wrote he transported all three involved deputies to University Hospital – Samaritan where they were tested for drugs and alcohol after the shooting.

JFD Incident Report 23-00181-01:

This report noted the JFD were dispatched at 2016 hours, and arrived at Dunham's residence at 2022 hours on August 5, 2023. The report indicated JFD Emergency Medical Technician Brandon Glass (EMT Glass) was the only member of JFD allowed to enter the scene. EMT Glass found Dunham to be non-responsive to questioning, have no pulse, no blood pressure, no respiration and neither of Dunham's pupils reacted to stimuli. After noting these observations EMT Glass exited the scene. EMT Glass re-entered the scene when requested to return to assist

in moving Dunham's person after BCI personnel had concluded their investigative activity within the scene.

ACSO Response to Resistance Report:

This document noted the involved deputies utilized verbal commands, tasers, and pistols during the encounter. The report noted "YES" next to the comment lines: "necessary for officer's defense" and "necessary to defend another."

Crime Scene Log:

This document noted the date and location of the incident as well as the time involved personnel entered and exited the crime scene and their purpose for doing so.

The document noted that Deputy Pennywitt started the crime scene log and secured the scene at 2011 hours on August 5, 2023, and the scene was released at 0150 hours on August 6, 2023.

SA Valente did not identify any other relevant information in these documents which had not previously been discovered throughout the investigation.

## Supporting Narrative By Dan Saylor, 08/07/23 00:05

On August 5, 2023 at approximately 1955 hours, the Sheriff's Office received a call for a male with suicidal ideation's. I was working a detail at the Ashland County Fairgrounds. I heard the call get dispatched and listened for who responded. I heard deputies Wilcox #331, Hemenway #328, and Pennywitt #333 all state they were in route. Dispatch advised the caller requested a silent approach. She also stated the male had firearms and that he might try suicide by cop. I heard all three units arrive on scene. Shortly there after I heard a deputy call out "shots fired" on the radio and asked for an ambulance. I immediately ran out of the fairgrounds and drove to the scene, which was approximately 2004 hours. I arrived on the scene at approximately 2013 hours. I saw deputies Wilcox and Hemenway by the cruisers parked by the road. They appeared to be in disbelief and stood there quietly. Deputy Pennywitt had crime scene tape in her hands and had taped off one perimeter around the scene at the time. I checked if everyone was okay, which they said they were. I asked what happened and if the gunshot was self-inflicted. Deputy Wilcox and Hemenway told me no, it was officer involved. They stated they attempted aid on the male and that he had no pulse. We requested the squad move up and come check the male. Brandon Glass from Jeromesville Fire Department entered the scene and confirmed the male to be deceased. Deputy Stone #334 and Ohio State Highway Patrol Sgt. Perrin then arrived on scene and assisted checking the area, taping off a second perimeter around the scene, and checking on the spouse of the male. I entered the scene with a sheet to cover the male at approximately 2038 hours.

I contacted my supervisor, Lt. Sims #303, and advised him of the situation. I contacted Detective Lt. Martin #305 next and he advised me to get the on-call detective and BCI on the way. I then contacted dispatch and requested the on-call detective, BCI, and to send out a supervisor text. I also spoke to Chief Deputy Blake #302 and the on-call detective Banks #315. The Coroner was also contacted and requested to come to the scene.

I took over the crime scene log and was told to send deputies Wilcox, Hemenway, and Pennywitt to our station. They were instructed to wait in enforcement and not talk to others without seeing a member of BCI first. Chief Deputy Blake and Sheriff Risner, Detective Banks and Dudte arrived on scene at approximately 2102 hours. Deputy Stone took over the crime scene log at this time. A coroner's assistant, Jenny Taylor arrived on scene at approximately 2208 hours. A member of BCI arrived on scene at approximately 2218 hours.

I left the scene at approximately 2226 hours. I went and got some food for the three deputies involved and brought it to the station. I also contacted our Chaplain and asked if he would come to station to speak to any of them if they wanted. He agreed and did come to our station. The union attorney also came to station for the three deputies. After the individuals got done eating and talking to the chaplain and union attorney I took them to University Hospital- Samaritan to get tested for drugs and alcohol per Chief Blake. Once completed at the hospital we returned to station, they secured vehicles and equipment and went home for the night. Nothing further at this time.

Narrative

JEROMESVILLE FIRE AND EMS DISPATCHED TO STAGE IN THE AREA OF 205 US ROUTE 250 FOR SHOTS FIRED. 3099 AND MYSELF (3067) RESPONDED TO THE SCENE DIRECT. WHILE ENROUTE TO THE SCENE I CONFIRMED WITH DISPATCH (300) THAT THE SCENE WAS SAFE FOR ENTRY. AFTER CONFIRMATION WE PROCEEDED TO THE SCENE. WE ARRIVED ON SCENE AND PARKED ON THE NORTH SIDE OF THE ROADWAY DIRECTLY ACROSS FROM THE INCIDENT. AS WE CROSSED THE ROAD WE WERE APPROACHED BY TWO DEPUTIES STATING THAT ONLY ONE EMS MEMBER WAS ALLOWED TO GO BEYOND THE TAPE AND THAT THEY WANTED ONLY ONE MEMBER TO GO TO THE PATIENT. AFTER SPEAKING TO THE FIRST TWO DEPUTIES, I TOLD THEM THAT I (3067) AM AN EMT AND 3099 IS A FIREFIGHTER. I MET WITH A THIRD DEPUTY WHO WAS KEEPING RECORD OF ALL PARTIES ENTERING AND EXITING THE BARRICADED AREA. ONCE I GAVE HER MY NAME AND DEPARTMENT AFFILIATION I PROCEEDED PAST WHAT WAS THE PRIMARY BARRICADE AT 2021. WHILE WALKING TO THE PATIENT WHO WAS LOCATED IN THE BACK YARD OF 205 US 250, I WAS TOLD TO STEP LIGHTLY AND AVOID ANY POSSIBLE EVIDENCE. I CAUTIOUSLY WALKED TO THE PATIENT. AS I APPROACHED THE PATIENT I NOTICED 3 HAND GUNS LAYING TOGETHER IN AN ORGANIZED FASHION. THE MALE WHO WAS JUST BEYOND THAT WAS LAYING SUPINE JUST SOUTH OF THE SIDE WALK. THERE WAS A LARGE POOL OF BLOOD NORTH OF THE PATIENTS HEAD AND APPROXIMATELY ONE FOOT OF AREA BETWEEN THE POOL OF BLOOD AND THE PATIENTS HEAD. I CAREFULLY CROUCHED DOWN TO THE PATIENT WHO WAS NOT RESPONDING TO ME ASKING HIM IF HE WAS OK. I ASKED HIM, "SIR CAN YOU HEAR ME?" WITH NO RESPONSE I FELT FOR A RIGHT CAROTID PULSE ON THE PATIENTS NECK AND DID NOT FEEL A PULSE. THE PATIENTS SKIN

## Extended Narrative

WAS COOL TO THE TOUCH. I ALSO NOTED THAT THE PATIENTS PUPILS WERE FIXED AND NOT REACTIVE, LOOKING STRAIGHT INTO THE SKY. I NOTED THE PATIENT HAD WHAT APPEARED TO BE A GUN SHOT WOUND TO HIS CHIN. I STOOD BACK UP AND CAUTIOUSLY WALKED BACK THE EXACT WAY I CAME IN TO THE PATIENT AS TO NOT STEP ON OR DISTURB ANY EVIDENCE. I DID NOT EXAMINE THE REST OF THE PATIENT DUE TO MY FINDINGS AND THE FACT I WAS TOLD TO BE IN AND OUT BY THE DEPUTIES SINCE THIS WAS A CRIME SCENE. I MET BACK WITH THE DEPUTY WHO RECORDED MY ENTRY TIME AND SHE MARKED DOWN THAT I LEFT THE BARRICADED AREA AT 2021. AFTER THAT I MET WITH 3099 AND THE OTHER SHERIFF UNITS ON SCENE AND TOLD THEM THAT I HAD NO RESPONSE FROM THE PATIENT AND NO PULSE. 3032 ARRIVED ON SCENE AT 20:22 AND I SPOKE WITH THE 2 MEMBERS FROM THAT UNIT. I ADVISED WE DID NOT NEED ANYTHING. WE THEN PROVIDED WATER TO THE DEPUTIES THAT WERE INVOLVED AND ASKED IF THEY NEEDED ANYTHING. BOTH DENIED ANY FURTHER. AFTER A APPROXIMATELY 45 MINUTES ON SCENE THE SHERIFF DEPUTIES CLEARED OUR SQUAD (3032) TO RETURN. I ASKED IF THEY NEEDED MYSELF (3067) AND 3099 TO REMAIN ON SCENE. THE DEPUTIES ADVISED ME TO SPEAK TO THE SHERIFF DETECTIVES WHO WERE JUST ARRIVING AND GOING TO BE IN CHARGE OF THE SCENE. THEY TOLD ME THAT I NEEDED TO STAY UNTIL BCI ARRIVED AND GIVE A STATEMENT IF REQUESTED. DURING OUR TIME WAITING ON BCI TO SHOW UP, 3067 AND 3099 PROVIDED ASSISTANCE TO THE SHERIFFS DEPARTMENT WHICH INCLUDED GETTING SOME BOTTLED WATER TO THE SCENE. I CALLED TO OUR STATION AND ASKED THE REMAINING MEMBERS TO BRING 2 CASES OF WATER FOR ALL OF THE PERSONNEL ON SCENE. THE DEPARTMENT MEMBERS DROPPED OFF THE WATER AND RETURNED. DURING THIS TIME MORE UNITS SHOWED UP SCENE INCLUDING THE CORNERS OFFICE. WE HAD A PRETTY LONG DELAY ON BCI. I DO NOT KNOW THE TIME LINE ON EXACTLY WHEN THEY ARRIVED. AFTER A SHORT WHILE OF BCI ON SCENE THEY SPOKE TO THE DEPUTIES AND ASKED IF WE ( THE FIRE DEPARTMENT) COULD PROVIDE THEM WITH EXTRA LIGHTING. I ADVISED THEM I WILL CALL THE CHIEF AND SEE IF HE COULD BRING THE LIGHTS. AFTER SPEAKING TO HIM HE WAS NOT AVAILABLE. I HAD 3099 RETURN TO OUR STATION WHILE I REMAINED ON SCENE TO GET THE LIGHTS. 3099 RETURNED A SHORT WHILE LATER WITH 4 PORTABLE LIGHTS FROM THE STATION. WE WERE REQUESTED BY BCI TO SET THE LIGHTS UP FOR THEM. AFTER LOGGING OUR ENTRY TIME, 3067 AND 3099 ENTERED THE BARRICADED AREA WITH BCI TO HAVE THEM INSTRUCT US ON SPECIFIC PLACEMENT OF THE LIGHTS. ONCE THE LIGHTS WERE IN PLACE 3067 AND 3099 EXITED THE BARRICADED AREA AND WERE SIGNED OUT BY THE DEPUTY RECORDING TIMES. 3067 AND 3099 THEN STOOD BY WITH OTHER UNITS WHILE BCI DID THE INVESTIGATION. AFTER BCI WAS DONE WITH THE INVESTIGATION, THEY ADVISED THE CORNER THEY WERE READY TO REMOVE THE BODY FROM THE SCENE. THE CORNER ASKED IF 3099 AND I (3067) COULD ASSIST HER IN PLACING THE VICTIM IN THE BODY BAG. WE ADVISED THAT WE COULD AND WE MADE ENTRY WITH HER AND BCI AFTER SIGNING IN WITH THE DEPUTY. WE CAUTIOUSLY WALKED TO THE PATIENT IN A SINGLE FILE LINE TO REDUCE ANY DISTURBANCE TO ANY EVIDENCE REMAINING. ONCE 3067, 3099, THE CORNER, AND BCI WERE AT THE VICTIM WE FOLLOWED THE INSTRUCTIONS GIVEN BY THE CORNER. SHE ADVISED US THAT WE NEEDED TO LOG ROLL THE PATIENT TO CHECK HIS POSTERIOR FINDINGS. AS A GROUP WE CAUTIOUSLY ROLLED THE PATIENT ONTO HIS SIDE. SHE ADVISED US THAT THERE WAS A TOTAL OF 4 TASER PROBES IN VARIOUS LOCATIONS ON THE PATIENTS BODY. IT WAS AT THAT TIME WE DISCOVERED ITEMS IN HIS POCKETS OF THE SHORTS HIS WAS WEARING. THE CORNER ALSO NOTED THERE WAS A PROBE IN HIS RIGHT SHOULDER. WHILE WE HAD THE PATIENT ON HIS SIDE THE CORNER REMOVED SEVERAL ITEMS FROM HIS POCKETS. IN THE PATIENTS RIGHT HAND POCKET WAS A SINGLE HOUSE KEY, A KEY RING THAT HAD ANTIQUE KEYS, AND A HAND MAGAZINE CLIP WITH ROUNDS IN IT. THE LEFT HAND POCKET SHE FOUND CIGARETTES AND A LIGHTER. ALL ITEMS WERE GIVEN TO BCI. AFTER THE EXAMINATION OF THE PATIENT WE FOLLOWED THE INSTRUCTION OF THE CORNER ON HOW TO PLACE THE PATIENT INTO THE BODY BAG. ONCE THE PATIENT WAS PLACED INTO THE BODY BAG, THE LIVERY DRIVER BROUGHT HER COT TO THE PATIENT. WE PLACED THE PATIENT ONTO HER COT AND SECURED WITH THE STRAPS. 3067 AND 3099 WHEELED THE COT TO THE LIVERY DRIVERS VAN WITH GUIDANCE FROM THE CORNER AND BCI MEMBERS. THE DEPUTY LOGGED OUR OUT TIME AND WE PROCEEDED TO THE LIVERY SERVICE VAN. AFTER PLACING THE PATIENT IN THE VAN WE MET BACK UP AT THE PRIMARY ENTRY POINT AND WAITED FOR BCI TO GIVE THE ALL CLEAR. ONCE THE ALL CLEAR WAS GIVEN. 3067 AND 3099 REMOVED THE 4 PORTABLE LIGHTS AND PLACED THEM IN THE APPARATUS FROM THE FIRE STATION. AFTER WE COMPLETED THAT TASK, BCI REQUESTED AS A COURTESY THAT WE (3067 & 3099) ATTEMPT TO WASH THE POOL OF BLOOD OFF THE SIDEWALK. WITH BCI AT OUR SIDE WE FOUND A LARGE PALE OF WATER IN THE BACK YARD AND USED A 5 GALLON BUCKET PROVIDED BY BCI TO RINSE THE SIDEWALK OFF. WE DID THE BEST WE COULD AND CONFIRMED WITH BCI THAT THEY WERE SATISFIED WITH THE RESULTS. ONCE WE TALKED EVERYTHING OVER WITH BCI AND THE SHERIFF DEPUTIES WE WERE ABLE TO CLEAR THE SCENE. I PUBLIC SERVICED DISPATCH (300) TO ADVISED THEM THAT WE WERE RETURNING AT 02:00 HOURS ON 8-6-2023. 3099 & 3067 RETURNED TO STATION WITHOUT INCIDENT. END OF REPORT. 19:55:26 8/7/2023


