**Narrative:**

On Wednesday, August 13, 2025, the investigation regarding the officer-involved critical incident that occurred in Akron, Summit County, Ohio, on August 17, 2024, was presented to a Grand Jury in the Summit County Court of Common Pleas by the Ohio Attorney General Special Prosecutions Section. The Grand Jury declined to file criminal charges regarding the actions of Akron Police Department [REDACTED] in relation to the death of Michael Jones.

All evidence in this case was returned to the requesting agency on August 19, 2025, and was signed for by Akron Police Department Officer Larry Rhodaback.

A case file, contained on a USB drive, was given to the requesting agency and was signed for by Akron Police Department Officer Larry Rhodaback on August 20, 2025.

Special Agent John Tingley and Special Agent Supervisor Charles Moran reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.

The Summit County Grand Jury No Bill document, the signed evidence return receipt from the requesting agency, and the signed receipt for the case file for the requesting agency are attached to this report. Please refer to those documents for further information.

Accordingly, this case is closed.
