NARRATIVE

AGGRAVATED MENACING/GUN CONFISCATED/NAMED SUSPECT

On Tuesday May 10th, 2022 while accompanied with P.O. Mazanec #2011 at 1934hrs we received a radio broadcast to 1120 E 67st in connection with the caller's neighbor in his backyard with a rifle. We were also advised that the male fired at least one round, possibly in the air.

Upon our arrival we spoke with [REDACTED] (victim) at her residence [REDACTED]. She stated that she arrived home then pulled into her driveway into the rear of her home. When she pulled in the back, she stated that she observed her neighbor, Robert Perkins (suspect), sitting on his back porch, facing her driveway. She began to turn around in her driveway. When she was turning around, she then observed him with a rifle on his lap pointed up towards the sky. [REDACTED] then reported the suspect fired one round. She stated she was unsure if the rifle remained pointed upwards or if he leaned it forward. [REDACTED] then got her dog out of the car and ran inside of her residence. [REDACTED] advised us that they have had issues with this neighbor in the past. She perceived the fire of the round in the air as threatening.

We then walked down her driveway towards the rear of her house. We observed Mr. Perkins, sitting on his back porch with a rifle, a black and silver AR style, on the table. We advised Mr. Perkins that we would be over to speak with him at his residence, and to not touch the rifle. We then conferred with Mr. Perkins in his driveway. He stated that he was sitting on his porch listening to music. He also stated that he just had his rifle sitting on the table. When asked if he fired his rifle, he denied. While conferring with Mr. Perkins, we observed a single spent shell casing on the floor of the deck, next to the table. We advised Mr. Perkins that we would be confiscating the firearm, and he would be a suspect in a report.
