On Thursday, June 13, 2024, at approximately 0220 hours, BCI Special Agent Stacey Fifer (SA Fifer) received a notification to respond to Youngstown for assistance regarding an officer involved critical incident.

SA Fifer initially responded to the incident location at Youngstown, Ohio. SA Fifer met with other BCI personnel at the scene and, subsequently, SA Fifer responded to Mercy Health – St. Elizabeth Hospital (St. Elizabeth) where the involved individual, Mathue O'Malley (O'Malley), was admitted for injuries sustained during the incident.

Upon arrival, SA Fifer spoke with Officer Steve Gibson (Officer Gibson) of the Youngstown Police Department in front of hospital room #3804, where O'Malley was located. Officer Gibson advised O'Malley's belongings were "bagged up" by hospital staff and were located in room #3804. Officer Gibson relayed that he was told he could leave the hospital when BCI arrived.

SA Fifer spoke with St. Elizabeth Registered Nurse Hannah Mogg (RN Mogg), who relayed that O'Malley had

RN Mogg was unaware of any other

She advised O'Malley was in critical condition and not expected to survive his injuries. No projectiles or bullet fragments were seen by medical staff during the course of O'Malley's medical treatment. SA Fifer took 3 photographs of O'Malley while at the hospital for evidentiary purposes (photographs attached). RN Mogg provided the

SA Fifer collected O'Malley's belongings that were contained in an unsealed brown paper bag and provided a BCI property receipt that was signed by RN Mogg (receipt attached). Contained in O'Malley's property were the following items:

- gold necklace with M pendant
- black apple watch
- black leather wallet with \$347.00 in U.S. currency, virtual wallet debit card, Amazon credit card, medical card, OH driver's license, and miscellaneous receipts
- tan pants (cut) with black cloth belt attached
- grey underwear (cut)
- (1) black athletic sock

SA Fifer secured the property in her vehicle at 0535 hours before returning to the incident location.

SA Fifer transferred the property to BCI Richfield. While in a sterile environment, the items were photographed, repackaged, and sealed in evidence bags/envelopes by SA Fifer (photographs attached).

At approximately 0818 hours, SA Fifer transferred all evidence items to Administrative Professional Nichole Jaklitch, who subsequently submitted the items to the BCI evidence room (evidence receipt attached).
