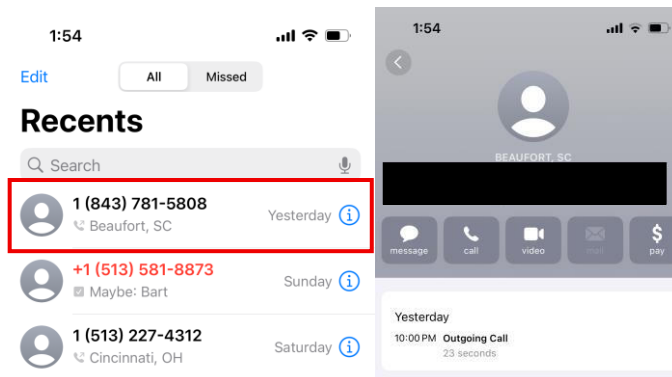
On June 5, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier (SA Frazier) learned that West Chester Police Department (WCPD) Sgt. Parrett and [REDACTED] had used their department-issued cell phones to attempt to contact the female victim, Tiffany Barnes (Barnes), during this incident.

On June 5, 2026, SA Frazier documented cell phone communication by taking screenshots from two WCPD cell phone devices. The following cell phones were voluntarily given to investigators and reviewed:

- 513-284-2958 – utilized by Sgt. Dustin Parrett
- [REDACTED] – utilized by [REDACTED]

There were several phone numbers listed for Tiffany Barnes, to include [REDACTED] and [REDACTED]. The phone number 283-210-7417 was believed to belong to the subject, Lorenzo Miller (Miller). During a review of the cell phones utilized by Sgt. Parrett and [REDACTED], the following communication was observed:

- 2200 hours - [REDACTED] made an outgoing call to [REDACTED] (Barnes) which lasted 23 seconds

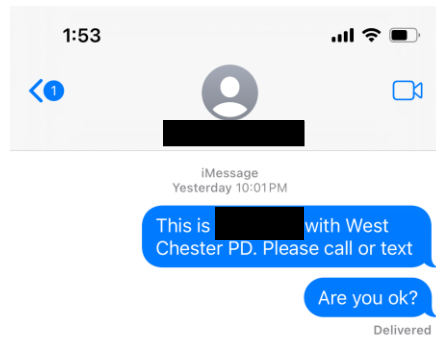

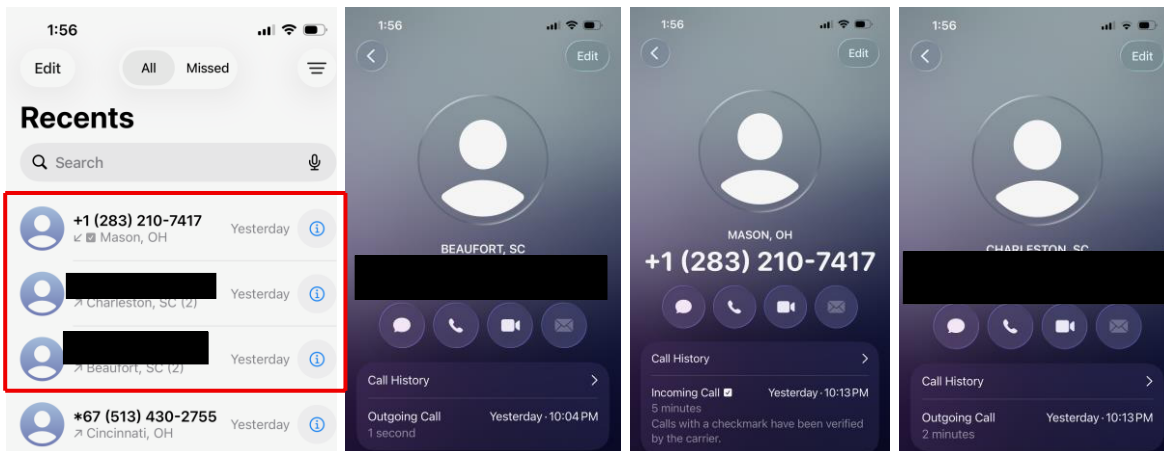

- 2201 hours - [REDACTED] sent a text message to [REDACTED] (Barnes), asking her to call or text him and asked if she was ok



- 2204 hours - Sgt. Parrett made an outgoing call to [REDACTED] (Barnes) which lasted 1 second
- 2213 hours - Sgt. Parrett received an incoming call from 283-210-7417 (Miller), which lasted 5 minutes
- 2213 hours - Sgt. Parrett made an outgoing call to [REDACTED], which lasted 2 minutes



- 2216 hours - Sgt. Parrett and Sgt. [REDACTED] both received a text message from [REDACTED] reading "Help."

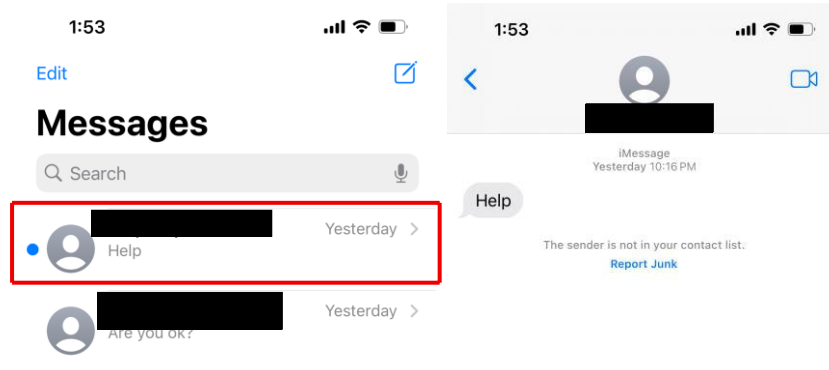
