On [REDACTED], the investigation regarding the officer-involved critical incident that occurred in Grove City, Ohio, on October 8, 2025, was presented to a Grand Jury in the Franklin County Court of Common Pleas by the Franklin County Prosecutor's Office. The Grand Jury declined to file criminal charges regarding the actions of Grove City Police Officers in relation to the death of Dominique Byrdsong.

All evidence in this case has been returned to the requesting agency. During the investigation, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.
