Narrative:

On March 19, 2025, at approximately 1331 hours, the Ohio Bureau of Criminal Investigation (BCI) Special Agents Dave Hornyak and Steve Seitzman interviewed Ndagimana Mugietra relative to the officer-involved critical incident that occurred earlier that morning on I-75 in Evendale, Ohio. The interview was recorded on a handheld digital recording device. This report is a summary only. The entire interview can be reviewed on the recording.

Mr. Mugietra provided the following information:

He was notified by family earlier in the day that his uncle, Samuel Munyarutete had been killed. He last saw Mr. Munyarutete approximately four months ago and does not know where he was last night. Contrary to what other family members reported to BCI, Mr. Mugietra stated that he has never given his uncle a ride anywhere. Mr. Mugietra specified that Mr. Munyarutete sometimes walks places and has been known to walk in the street. Regarding his uncle's mental health, Mr. Mugietra stated, "...you can see that his mind is not good."

Mr. Mugietra stated that on March 18, 2025, he was at work from 1400–1900 hours, went home, and then returned for his next shift on March 19, 2025, beginning at 0600 hours. His shift will finish at 1800 hours later today.

Mr. Mugietra stated that he is from Uganda, has completed the process to obtain U.S. permanent residency (green card) but has not yet received it. Mr. Mugietra said that Samuel Munyarutete did not have a green card either. Mr. Mugietra said he knew that Mr. Munyarutete was taken to jail last week, but stated that he does not know much about his uncle.

The interview terminated at approximately 1342 hours.
