Narrative:

On Wednesday, October 15, 2025, the investigation regarding the officer-involved critical incident that occurred in Alliance, Ohio, on January 16, 2025, was presented to a Grand Jury in the Stark County Court of Common Pleas by the Stark County Prosecutor's Office. Upon conclusion of the grand jury presentation Stark County Assistant Prosecuting Attorney Kristen Mlinar informed Special Agent Valente the Grand Jury declined to file criminal charges regarding the actions of Alliance Police [REDACTED] and [REDACTED] in relation to the deaths of Mason French and Stacy Pride.

All evidence in this case has been returned to the requesting agency. A copy of the evidence return receipt was attached to this report.
