The abstract under consideration was prepared by H. M. Whitcraft, Abstracter, under date of October 20, 1924, and pertains to premises located in sections 10, 11 and 14 of Township No. 11, Range No. 18, and totaling according to the deed and abstract 486 acres.

On examination of said abstract same shows a good and merchantable title to said premises in Elizabeth Iles, widow, J. Clifford Iles and Hattie Iles, his wife, subject to the following exceptions:

I find several irregularities and deficiencies in the early history of the title under consideration, but in view of the fact that a considerable length of time has elapsed since the transfers that appear to be irregular and deficient, same can be safely disregarded. In this connection attention is directed to an affidavit appearing at section 112 of the abstract which shows that Jeremiah Iles, the predecessor in title of the present owners, has been in open notorious and uninterrupted possession of the premises under consideration for a considerable length of time.
