Narrative:

On the morning of September 10, 2024 at approximately 0130 hours, Lamine Mahmoudi (Mahmoudi), of 235 Chittenden Avenue, Columbus, Ohio, was killed during a confrontation with officers from the Columbus Division of Police (CPD). Mahmoudi was armed with a meat cleaver and butcher knife, and incident took place in the rear parking lot of the CPD Precinct 4 substation. The Ohio Bureau of Criminal Investigation (BCI) was requested by CPD to handle the Officer-Involved Critical Incident investigation. The six involved officers were identified as:

According to the suspect (Mahmoudi) disregarded the pleas and commands of the officers. described the moment the officers responded with force:

stated that he assisted officers with handcuffing Mahmoudi. He reported seeing injuries to Mahmoudi's head, chest, and legs. He said he suggested to others that they check the residences north of the alley for potential bullet strikes and bystander injuries, since the buildings were in the backdrop of the shooting.

Stated that he then reported to the Columbus Police Training Academy where he waited for his representation from the FOP.

said he thought he fired three times. From a round count when his weapon was

| collected, learned that he actually fired five rounds. Likewise, initially estimated that he was twenty-five to thirty feet from Mahmoudi when he shot. After reviewing his body-worn camera footage, however, stated he realized he was much closer, as in fifteen to twenty feet. | | | | |

STATEMENT OF OFFICER

This statement is regarding my involvement in an officer involved shooting that occurred on Monday, September 10, 2024 between 1:25am and 1:35am near the Columbus Division of Police (CPD) Substation 4 located at 248 E. 11th Avenue. This is a voluntary statement given as part of the criminal investigation conducted into the matter by the Bureau of Criminal Investigations (BCI).

I was hired by the CPD on I do not have any previous law enforcement experience. I do not have any prior/current military service. My regular assignment at CPD is Patrol My regular duty hours are with I have been in my unit since I was released from probation in On Monday, September 10th, I was on my regular assignment. I was dressed in the patrol uniform of the day, which includes navy pants and a navy short sleeved shirt with my CPD badge identifying me as police officer on the front. I was not wearing a hat. I was clearly identifiable as a Columbus Police Officer. My body worn camera (BWC) was mounted on the center of my chest. I was armed with a department-issued Smith and Wesson M&P 9mm 2.0 with standard department-issued ammunition. My weapon has a TL-1 HL light made by Streamlight. I am current in my range qualifications with my sidearm and the light. I was not carrying any backup weapons. I was driving CPD Cruiser I had no partner.

I am left-hand dominant. I was in good health at the time of this incident. I was not taking any medication that would in any way affect my ability to carry out my responsibilities and duties as a police officer. I had worked special duty at a Kroger liquor store located at:

prior to my shift. This was a special duty assignment that I have regularly worked for a number of years. I had plenty of sleep prior to my special duty/shift. I was

not under any unusual stress. I do not wear a hearing aid, nor do I have any problems with my hearing. I do not wear glasses, nor do I have any problems with my vision.

About a half hour after arriving for my shift at Substation 4, I was dispatched with several other officers from Zone 4 to 235 Chittenden Avenue on a 33-A (our 10-code for knife). There had been previous calls at the address due to the actions of one of the roommates (suspect). When we were dispatched to that location, I believe another roommate had called because the suspect had a knife inside the residence. The address was a brick duplex-styled home, which had multiple entry points for more than one apartment. There was a set of stairs (external) on the right (east) side of the residence leading to the apartment that the suspect was believed to live.

The parking lot of Substation 4 is short distance from the parking area that was used for the 235 Chittenden Avenue address. Because I was in the middle of loading up my cruiser, I went on foot to the rear of the address and was the third officer to arrive. I did go back for my cruiser when it became evident one was needed and drove it to the rear of the building. Other officers at the call included: Sergeant Van Dusen,

The suspect continued to walk east. The lighting in the parking lot made it easy to see the knives in the suspect's hands as they would glint when the edges caught the light. It appeared to

We began to render aid. The knives were placed away from the suspect. I helped other officers cuff the suspect. Officers began compressions. I aired that the alley behind the substation would need to be blocked off, as well as the entrances. The suspect had obvious wounds in his head. He had multiple wounds in his chest. I pulled down his pants to check for wounds in his legs, of which there appeared to be several. Officers continued compressions until medics arrived. I did mention at some point that the residence north of us should be checked, as it was the backdrop to the shooting and I wanted to make sure that no one else had been injured. I had no further involvement in the incident. I went to the CPD Training Academy to await my FOP representation.

I now know that I fired five (5) times. When I fired, I fired from a standing position with both hands. I used my sights. I fired at the suspect's center mass. There was plenty of light in the parking lot, but I also used my weapon's light. I fired north. I did not see any officers or civilians in my backdrop. My backdrop was the fence and vehicles directly behind the suspect. I believed I

was approximately 25-30 feet from the suspect. I did not fire from cover. At the time, I didn't have the time, distance, or barrier necessary to successfully deploy less than lethal force. I stopped firing once the suspect had fallen to the ground and was no longer a threat.

When I fired, there had been multiple calls regarding the suspect that day, who had been reported as armed with a knife. There had been several attempts to get him to come out of the house peacefully prior to this interaction with him, which he refused to do. The suspect was given multiple commands for several minutes as he walked east down the alley and failed to comply. He gave no indication that he was going to stop moving in our direction or drop his weapons. Instead, the suspect turned towards us showing us both knives and then walked towards officers in the parking lot. He made what I perceived to be a threatening movement in our direction. At the time, I did not have any other reasonable alternative other than to fire to protect the lives of my fellow officers and myself who were in imminent danger of death or extreme bodily harm from the suspect.

I know the suspect's name was Lamine Mahmoudi. Prior to September 9th and 10th, I do not remember having any prior interactions with the suspect either personal or professional.

Upon review of the video of the incident, the incident went much faster and the suspect was closer to officers than I remembered (approximately 15-20 feet). Otherwise, the videos do not materially alter my recollection of events.
