Narrative:

On Monday, October 27, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Douglas Burke (Burke) met with Scott and Lisa Corbin (Scott and Lisa) in Findlay, OH. The purpose of meeting with Scott and Lisa was to return personal property of Robert Norton (Robert) to Lisa, the daughter of Robert. Robert was the subject involved in the Officer-Involved Critical Incident (OICI) at 1642 Cherry Lane, Findlay, OH 45840 on October 22, 2025, and succumbed to his injuries at the time of the OICI.

SA Burke (with assistance from Administrative Professional Tracy Lembke) returned Robert's personal property items to Lisa which had been collected at Blanchard Valley Hospital (BVH) in Findlay, OH and the Lucas County Coroner's Office (LCCO) prior to the autopsy of Robert. Robert's personal property items had been stored in the BCI Bowling Green Evidence Room for safekeeping during that time. Lisa signed the Evidence Receipt Sheet acknowledging possession of Robert's personal property. See attached Evidence Receipt for further details of items returned.
