**Narrative:**

On Monday, November 17, 2025, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Union Township Police Department (Clermont County) to investigate an Officer Involved Critical Incident that occurred near 4272 Cider Mill Drive, Union Township, Ohio, resulting in the death of Thomas Noble (Noble).

On Tuesday, November 18, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier (SA Frazier) responded to the Hamilton County Coroner's Office, located at 4477 Carver Woods Drive, Blue Ash, Ohio 45242, to attend the post-mortem examination (autopsy) of Noble. Also present for the autopsy was Union Township Police Lt. Scott Blankenship, a Union Township Police Investigations Sergeant, and Detective Bryan Taylor.

The post-mortem examination was conducted by Dr. Jennifer Schott, M.D. Following the autopsy, Dr. Schott provided a preliminary autopsy report, which noted the following:

SA Frazier received evidence from the autopsy by Autopsy Technician Zach Caudill. The following evidentiary items were received:

- One (1) forensic package containing right and left nail clippings, 1 nail clippers, 1 head hair, and 1 bullet box (chest)
- Fingerprint card collected from Noble
- Blood card collected from Noble

On November 19, 2025, SA Frazier transferred the autopsy evidence to Crime Scene Technician Holly Ryczek.
