Narrative:

On Monday, November 22, 2021, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Collins (SA Collins) received Kyle Veyon's (Veyon) medical records from Grant Medical Center. The records were obtained pursuant to a court order. SA Collins reviewed the medical records and noted the following:

Veyon's medical records consisted of 70 pages. The records indicated Veyon's date and time of death was 9/29/2021 @1037 hours. [REDACTED]

[REDACTED] The records further indicated Veyon arrived by ambulance at 0955 hours to the Trauma Center. Attending Provider: David William Schmidt, MD.



It is further ordered that Ohio Health not notify any person (including Kyle Veyon) of the existence of this order for 90 days.

The failure to comply with this court-ordered Investigative Subpoena may result in a contempt of court citation. However, you can comply with this Investigative Subpoena without the court appearance scheduled below by providing the requested information to the law enforcement officer who requested this subpoena, and whose contact information is set forth below, prior to the date scheduled for the appearance.
