DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for the Department of Education, and R. W. Loomis, of Columbus, Ohio. This contract covers the construction and completion of Combined General Contract, Plumbing, Heating and Electrical Contracts for Head House for Greenhouse—Reconstructing Greenhouse, State School for the Deaf, Columbus, Ohio, and calls for an expenditure of two thousand eight hundred and twelve dollars (\$2,812.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. Inasmuch as the amount involved in this contract is less than five thousand dollars (\$5,000.00), the consent of the Controlling Board to the expenditure is unnecessary.

In view of the fact that the amount of the contract is less than three thousand dollars (\$3,000.00), no bond is required.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required

by law and the contract duly awarded. Also it appears that the law relating to the workmen's compensation has been complied with.

Finding said contract in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other data submitted in this connection.
