Narrative:

On October 3, 2023, at about 2300 hours, the Ohio Bureau of Criminal Investigation was requested by Chief Ronald Fusco (Fusco) of the Hubbard Township Police Department (HTPD) to conduct an independent investigation of the facts and circumstances surrounding an incident and an officer-involved shooting which occurred in the area of 7498 Van Ness Avenue, Hubbard, Ohio 44425, Trumbull County.

BCI Special Agent (SA) Chuck Moran responded to assist, arriving at about 0030 hours on October 4, 2023. SA Nick Valente and SA Charlie Snyder also responded to assist. Additionally, BCI Crime Scene Unit Special Agent Supervisor Ed Lulla responded to document the scene and collect pertinent evidence.

The shooting incident involved a male subject, Shawn Thomas, a member of the Ohio State Highway Patrol, and a member of the Vienna Township Police Department. The incident resulted in the death of Shawn Thomas.
