**Narrative:**

On the morning of September 10, 2024, at the request of the Columbus Division of Police, members of the Ohio Bureau of Criminal Investigation (BCI) Special Investigations and Crime Scene units responded to an Officer-Involved Critical Incident at the Columbus Police Precinct 4 substation. An involved subject, Lamine Mahmoudi, died from injuries sustained during the incident. While processing the scene, Crime Scene units located a hospital band on Mahmoudi's left wrist. Information from the wrist band indicated that Mahmoudi had been admitted to Grant Medical Center only days prior on 9/07/2024.

On September 12, 2024, BCI Special Agent (SA) James Gore served a subpoena to Grant Medical Center for Lamine Mahmoudi's medical records. The purpose of the subpoena was to obtain information that could possibly help ascertain whether or not Mahmoudi had any psychological or physical conditions that may have contributed to the events leading up to the critical incident. The timeframe of the subpoena was for one year, from 9/10/2023 through 9/10/2024. The records were received on 9/19/2024.

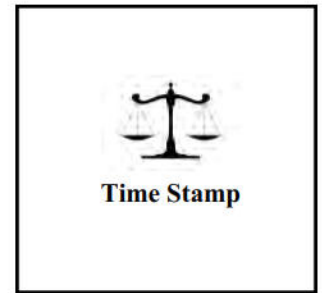




