Narrative:

On November 19, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of University Heights Police Officer Chad Goldberg (Officer Goldberg) during this incident.

Amped Replay was used to review the video.

SA Valente made working copies of the two BWC videos created by Officer Goldberg and placed the copied videos in a folder on his BCI issued laptop. The working copies of the videos were used for the review.

The recording began as Officer Goldberg exited his cruiser on Yellowstone Road and approached the scene of the officer-involved shooting which had already transpired by that time.

At approximately the 00:03:43 mark of the recording, Officer Goldberg encountered Jacquelyn Fortson (Jacquelyn) standing on the sidewalk in front of the driveway where the subject was then laying. Officer Goldberg asked Jacquelyn where she was going and if she would walk away from the scene. Jacquelyn stated she lived "here" and pointed to 1309 Yellowstone Road. Jacquelyn then volunteered, "I just ran away when I heard the shots." Jacquelyn repeated this statement a second and third time to Officer Goldberg as he escorted her down the sidewalk to the other side of her home where Ferrel Thomas (Ferrel) and Genisis Thomas (Genisis) were then standing.

Officer Goldberg and a fellow officer then spoke with a resident of 1295 Yellowstone Road and confirmed no one in that home was struck by gunfire. No derivative works were made from this recording.
