**Narrative:**

On Monday, January 13, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Goudy received documents from Liberty Township Police Department (LTPD) Detective Jeffrey Palmer II (Palmer). The records, which were requested, included any reports pertaining to the December 16, 2024, officer-involved critical incident, except for any statements made by the involved officers. SA Jon Lieber (Lieber) reviewed the documents and noted the following:

A total of 9-pages were received related to LTPD incident # [REDACTED].

The report consisted of incident information, computer-aided dispatch (CAD) records, as well as report supplements from Officer Mike Shuster (Shuster) and Detective Palmer.

The incident information section listed the incident date of December 16, 2024, at 1440 hours. The location of the incident was Harbor Freight, 3487 Belmont Avenue, Liberty Township, OH.

Two supplemental reports were written by Officer Shuster. One report detailed the next of kin notification to Cain's family. During the next of kin notification, Cain's stepfather, Thomas Brydon (Brydon), stated that he believed that Cain "had this coming" due to Cain's multiple contacts with law enforcement, previous felony convictions, and drug abuse. Brydon also stated that he was aware that Cain had a stolen vehicle, and a rifle (.22 caliber Savage) and that Cain's behavior prohibited him from coming around the house. The other report written by Officer Shuster detailed the obtaining of medical records from Mercy Health related to the treatment of Jason Cain.

Two supplemental reports were written by Detective Palmer. One report detailed the finding of a cartridge case in the Harbor Freight parking lot by Liberty Township Road Superintendent Wayne Hickman. The other report detailed communication with the Mahoning County Coroner's Office.

**Supplement Title:** Family Notification

---

With the assistance of the South Pymatuning Police Chief, Mathew Roth, I was able to identify and locate next of kin for Jason Cain. I spoke with Jason's step father, Thomas Brydon, who is married to Jason's mother Terry Cain Brydon. When asked, Thomas Brydon stated that Terry was emotionally in no condition to talk. I choose to inform Thomas of the OIS with Jason Cain. He stated that he saw the news footage with the stolen Jeep and figured that incident involved Jason but was not certain. Thomas and I spoke about the incidents leading up to the call at Harbor Freight. He was aware of the stolen motor vehicle, license plate and rifle (22 cal. Savage) and as a result of Jason's behavior prohibited him from coming around the house. Thomas was also aware of some additional theft investigations involving Jason and the Hermitage Police Department. Based on these findings Thomas stated that Jason "had this coming". When asked to expound on that comment, Thomas discussed the multiple run-ins with law enforcement, previous felony convictions, and drug abuse. Thomas stated that he was not originally aware of the drug abuse but learned this information from South Pymatuning PD. Thomas added that stealing vehicles and firearms would eventually catch up to Jason.

Thomas inquired if his stolen rifle was located inside the Jeep. He was informed that the vehicle and its contents will not be inventoried until the end of the week and if any relevant property is discovered he will be made aware. I requested that Thomas and his wife keep the communication lines open to discuss this matter in the future. He agreed that they would be willing to talk after the emotions have settled.

The family was informed that Jason was currently at Mercy Heath St Elizabeth Hospital Youngstown, Ohio receiving medical care.
