#### Narrative:

On September 20, 2023, Alliance Police Department (APD) Lieutenant Don Wensel provided Ohio Bureau of Criminal Investigation (BCI) agents with records of prior Alliance Police Department APD interactions involving the subject of the September 3, 2023 officer-involved shooting, George Appleby (Appleby). BCI Special Agent (SA) Nick Valente (Valente) reviewed these records and noted the following:

- Accident 050426456
  - o In 2005 Appleby was a passenger in a vehicle involved in a collision.
- Incident 21-9003
  - Appleby was arrested by APD on an outstanding warrant out of the Portage County Sheriff's Department for failure to appear and costs stemming from an original charge of Operating a Vehicle While Impaired.
- Incident 13-6782
  - Appleby was arrested by APD on an outstanding warrant out of the Portage County Sheriff's Office for failing to pay fines stemming from an Operating a Vehicle While Impaired offense.
- Incident 18-00926
  - o Appleby was arrested on a warrant out of the Alliance Municipal Court for an original charge of Domestic Violence.
- Incident 18-00658
  - O Appleby was issued citations for local ordinance violations of drug abuse (marijuana) and possession of marijuana drug paraphernalia.
- Incident Occurring in 2017 (Without Case Number Assigned)
  - o Appleby was arrested on a warrant out of the Stark County Sheriff's Office for trafficking heroin.
- Incident 13-02572
  - Appleby was arrested for selling heroin and crack cocaine to a confidential informant in the city of Alliance.

#### • CAD Call 342642

o In 2003, Appleby called police and advised them that his son was assaulted by his mother's boyfriend. Police investigated and Appleby's son was returned to his mother.

#### • CAD Call 519696

o In 2005, APD responded to a complaint of Appleby being intoxicated and causing problems. Appleby left the residence and the matter was settled.

#### • CAD Call 708032

o In 2007, Appleby called police reporting his girlfriend at the time sold his phone. APD determined the female owned the phone and the matter was resolved.

#### • CAD Call 847799

o In 2008, APD responded to a call of a man who was intoxicated and screaming obscenities. APD located the male, Appleby, who was advised to calm down and sent on his way.

### • CAD Call 1725069

In 2007, Appleby called APD and reported that his ex-girlfriend created a
Facebook account in his name and used it to spread false information about him.
Appleby could not locate the Facebook account when speaking with police and stated he would contact them later after finding it.

### • CAD Call 1751239

o In 2017, Appleby tried to start a fight with the child of his then girlfriend. The child walked away from the incident. APD advised Appleby he would need to allow the female (cohabitating) into their apartment upon her arrival home.

#### • CAD Call 1940703

o In 2019, APD was called to assist Appleby in removing belongings from a residence.

#### • CAD Call 1942484

o In 2019, Appleby called APD and reported a male pushed in his front door and Appleby locked the male in the basement. APD responded and arrested the male for Canton PD on a warrant.

#### • CAD Call 1942554

o In 2019, Appleby called APD regarding a male removing property.

#### • CAD Call 1942570

o In 2019, Appleby called the APD and stated he was afraid to go into his house and he believed unknown people were sneaking around and would attempt to kill him.

#### • CAD Call 1960901

o In 2019, a neighbor called APD and reported people were fighting in the residence. When APD arrived, all parties stated everything was okay.

#### • CAD Call 1962325

o In 2019, a man called APD and reported Appleby approached him reporting someone punched Appleby in the mouth. APD arrived and found Appleby intoxicated. Appleby appeared to have fallen down a flight of stairs. His allegation of being the victim of an assault could not be corroborated.

## • Incident 02-03107

o In 2002, APD arrested Appleby for domestic violence after he struck his then girlfriend in the face with his fist multiple times.

#### • Incident 05-05046

o In 2005, Appleby was playing cards with a group of people when a female assaulted another female. There is no record of Appleby being involved in the altercation beyond being present at the time.

## • Incident 08-03145

o In 2008, Appleby was mentioned in an APD police report as living with a female who refused to leave the home of her daughter and was arrested.

### • Incident 13-01211

o In 2013, police responded to a complaint of a possible methamphetamine lab. Suspected marijuana and unknown pills were seized for testing. Appleby was present in the home at the time.

#### Incident 20-01587

o In 2020, APD arrested Appleby for assault, obstructing official business, and possession of marijuana after Appleby struck a woman in the throat and chest, possessed marijuana, and faked a medical emergency. In 2021, Appleby was arrested on a bench warrant for failure to appear in refence to this case.

#### • Incident 21-02187

o In 2021, APD responded to a disturbance call. APD found Appleby lying on the ground outside, unable to stand up, and highly intoxicated. Appleby swung at an E.M.T. who responded to the scene to provide aid to him. Appleby was arrested for disorderly conduct intoxication.

#### • Incident 22-00221

0	In 2022, Appleby was arrested by APD for felonious assault after he was found to
	have struck in the face and strangled her. Note that

- Incident 22-02011
  - o In 2022, APD Officer Toussant responded to a menacing call. The complainant alleged that Appleby threatened to kill him. The complainant believed Appleby could follow through on the threat. Note that Officer Toussant is the APD officer who shot and killed Appleby on September 3, 2023.
- Incident 94-05781
  - o In 1994, Appleby was named the suspect in an aggravated burglary complaint. No further information regarding this allegation was included in the report.
- Incident 95-01620
  - In 1995, Appleby was arrested for Domestic Violence and Firing/Discharging a Weapon. No further information regarding this incident was included in the report.
- Incident 98-11032
  - o In 1998, Appleby was listed as the victim of a petty theft. No further information regarding this incident was included in the report.
- Incident 1902080
  - o In 2019. Appleby was cited for marijuana possession and marijuana paraphernalia possession. Appleby was also arrested on an outstanding warrant for failure to appear in an unrelated matter at the time.

On 11/20/05, I responded to 542 S. Arch and met with Diana Adams who stated she was just assaulted by Brandi Hyronimus. Adams stated she and Hyronimus were playing cards with Wade Barnes and George Appleby when all of a sudden, Hyronimus jumped across the table, causing the tables legs to break, tackled Adams to the ground and began to assault and bite her. Adams did suffer injuries to her arm and neck. There was a large scratch, approx 10 inches long, on the left side of her neck, and a bite mark on her right forearm approx 1 1/2 inches long.

Hyronimus was gone prior to our arrival, and was said to have left in a blue in color Dodge Neon. We attempted to located Hyronimus but had negative contact. Adams reports that this has happened in the past, and wants to pursue charges. She was advised to contact the Law Director on Monday morning 11/21/05.

Photos were taken of Adams injuries and the damage to the table. Adams and Barnes gave written statements. Photos were logged into evidence.

On 07/17/2020 at approx. 1843hrs I was dispatched to an assault report. Upon arrival Sherry Patton authored a written statement advising that George Appleby grabbed her throat at 825 S Liberty Ave. at Rick Horton's house. Patton's boyfriend, Steven A. Terrell, witnessed the assault and also authored a written statement, but advised he shoved her upper chest/throat area. Appleby was located at 846 S Linden and advised that Horton would be able to clear up the story. We transported Appleby to 825 S Liberty Ave to speak to Horton, who advised that he was not home when this allegedly took place. Appleby was arrested for Theft and upon searching his pockets a small bag of marijuana was located in his right pocket. Appleby was also charged with Drug Abuse- Marijuana.

The defendant was then taken to the City of Alliance Jail to be booked and processed. Once in the sallyport, the defendant displayed symptoms of a medical emergency (seizing up, went limp, and was not visibly breathing. EMT was called to provide medical attention to the defendant and chest compressions were performed. Once at the hospital the defendant became combative with officers and hospital staff, delaying the performance of our duties.

Once medically cleared for incarceration, the defendant was taken to the Stark County Jail on charges of Assault, Obstructing Official Business, and Possession of Marijuana. Once at the sallyport of the Stark County Jail the defendant again attempted to create the appearance of a medical emergency, that the Stark County Jail nurse was able to determine did not need medical attention.

The Alliance Community Hospital found that nothing required medical attention and that his EKG came back normal.

Patton had redness to her chest but she advised that she has a medical condition that causes it.

Martin also said that he is in fear for his life and the life of his dog, because Mr. Appleby may actually take action on his statements. Martin was advised that this report would be forwarded to the Alliance Law Director's Office for review while I attempt to locate, identify and interview the witnesses from the Alliance Catholic Worker.
