Narrative:

On 02/24/2026 at approximately 1410 hours, Special Agent Edward Lulla (S/A Lulla) was contacted by Lead Crime Scene Technician Michael Rostocil. He advised that the Parma Police Department was involved in an officer involved critical incident in Brooklyn, Ohio. The agency requested assistance from the Ohio Bureau of Criminal Investigation (BCI) in examining the scene and collecting potential evidence. S/A Lulla along with Special Agent David Hammond accepted the request.

At approximately 1700 hours, the agents arrived at the initial crime scene, located in the roadway at 10810 Brookpark Road. There, S/A Lulla was requested to examine a GMC Acadia that had apparently been struck by a bullet during the incident.

S/A Lulla was directed to the vehicle which was parked in the parking lot of PT Solutions, located at 10801 Brookpark Rd. There, S/A Lulla spoke to the vehicle's owner, Danny Lee Murphy (C/M 4-22-54), who stated while turning left (east) from Commerce Parkway West onto Brookpark Road, his vehicle was struck by an apparent bullet. Murphy agreed to a search of his vehicle and signed a consent to search form, which was later uploaded into Matrix.

While examining the vehicle, an apparent Ballistic Impact (BI) was observed on the vehicle's left front (driver's) door.

Location of Ballistic Impact

An examination revealed that the bullet perforated the lower corner of the B pillar on the left front door. Upon opening the door, it was determined that the bullet had continued and penetrated the vehicle's inner B pillar (BI #1.1) but could not be recovered.
