**Narrative:**

On May 31, 2022, Special Agent Douglas Eveslage with the Ohio Bureau of Criminal Investigation (BCI) reviewed the autopsy of Matthew Ryan Todhunter (Todhunter) at the Montgomery County Coroner's Office 361 W. Third Street, Dayton, Ohio. Todhunter died as a result of an Officer-Involved Critical Incident at 1551 Meadowlark Lane, Marysville, Union County, Ohio.

Lee Lehman, Ph D, M D, Chief Deputy Coroner, Forensic Pathologist, conducted the autopsy of Todhunter with the assistance of several autopsy technicians. [REDACTED]
