Narrative:

On Tuesday, December 10, 2024, at 1658 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) and interviewed Patricia Fields (Fields), relative to her purchase of a Taurus pistol, model G2C, serial #AEB092621 on May 5, 2023, from Range USA in Akron, OH. This pistol was recovered on the person of Jazmir Tucker on November 28, 2024. Prior to the telephone interview, SA Lieber and SA John Tingley attempted to locate Fields at 265 North Thomas Road, Tallmadge, OH. No answer was received at the door, so SA Lieber left a door hanger with his business card on the apartment door.

At 1658 hours, Fields called SA Lieber from telephone [REDACTED]. Fields stated that she recalled purchasing a firearm a while ago, but she did not remember what kind of firearm it was. SA Lieber asked what happened to the pistol. Fields stated "Um, I believe it was stolen cause I haven't seen it in a while, like a long while." SA Lieber asked if Fields had reported that the pistol was stolen to any police department. Fields stated that she did not report it stolen because she was told when she purchased it that if the gun was ever lost or stolen there was nothing she could do about it "because they don't like run, they don't put the numbers in the computer or something no more. Like register it under your name, that's what they told me but apparently, they did" [1:10]. SA Lieber confirmed that she was provided that information by Range USA.

Fields stated that she could check with her daughter (Marcella Fields) to see if she could recall any information.

At 1726 hours, Fields called SA Lieber and stated that she believed that the gun went missing between October and December of 2023. Fields stated that is when they were moving, and it is possible that one of the people that were helping them move had taken it. Fields stated that she did not use a moving company, but she used several people, some of which she didn't know. Fields stated that she was moving from the

apartment building across from the board of elections at Grant and Exchange streets (possibly the EnVision apartments) to a duplex on Cramer Street.

SA Lieber asked how many people were helping her move. Fields said about 3 to 4 people. SA Lieber asked if she recalled their names. Fields said that it was one female and two males. Fields said that she did not know their names, but her daughter may know their names. SA Lieber asked Fields to check with her daughter and either call or text message SA Lieber back with any additional information.

On December 13, 2024, at 1541 hours, SA Lieber sent a text message to Fields asking if her daughter was able to recall the names of anyone that helped them move.

On December 17, 2024, at 1715 hours, SA Lieber sent a text message to Fields asking if her daughter was able to recall the names of anyone that helped them move.

On December 27, 2024, at 1535 hours, SA Lieber called Fields at [REDACTED]. No answer was received, and the voicemail box was not set up, so SA Lieber was unable to leave a message. At 1541 hours, SA Lieber sent a text message to Fields asking if her daughter was able to recall the names of anyone that helped them move.

On January 7, 2025, at 1250 hours, SA Lieber called Fields at [REDACTED]. No answer was received, and the voicemail box was not set up, so SA Lieber was unable to leave a message. At 1252 hours, SA Lieber sent a text message to Fields asking if her daughter was able to recall the names of anyone that helped them move.

On January 7, 2025, at 1317 hours, Fields called SA Lieber. Fields stated that her mother is in critical care at the hospital. Fields stated that she would contact her daughter to see if she had any information. Fields stated that she would call or text SA Lieber after she speaks with her daughter.

On January 15, 2025, at 1518 hours, SA Lieber sent a text message to Fields asking if she was able to connect with her daughter regarding the identity of the people that helped them move.

On January 21, 2025, at 1532 hours, SA Lieber sent a text message to Fields stating that SA Lieber could contact her daughter directly if she would provide contact information.

As of January 31, 2025, no response was received from Fields. If a response or information is obtained at a future time, a separate report will detail that information.
